**A RESOLUTION OF THE BOROUGH COUNCIL OF THE
BOROUGH OF GETTYSBURG, ADAMS COUNTY,
PENNSYLVANIA, APPOINTING MEMBERS TO THE
GETTYSBURG BOROUGH LOCAL HUMAN RELATIONS
COMMISSION.**

WHEREAS, the Borough Council of the Borough of Gettysburg (hereinafter referred to as the “Borough Council”) adopted, enacted and ordained the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance, Ordinance No. 1475-20, on December 14, 2020, which is codified as Chapter 1, Part 13 of the Code of Ordinances of the Borough of Gettysburg (hereinafter referred to as the “Ordinance”); and

WHEREAS, pursuant to subsection 1-1307.1.A. of the Ordinance, the Borough Council shall appoint by resolution five (5) individuals as members of the Gettysburg Borough Human Relations Commission (hereinafter referred to also as the “Local Human Relations Commission”) to serve staggered and overlapping terms; and

WHEREAS, pursuant to subsection 1-1307.1.A. of the Ordinance, the Borough Council may appoint by resolution at least one (1) but no more than three (3) alternate members of the Local Human Relations Commission; and

WHEREAS, pursuant to subsection 1-1307.1.B. of the Ordinance, members or alternate members of the Local Human Relations Commission must be either residents of the Borough of Gettysburg (hereinafter referred to as the “Borough”) or must be employed on a full-time basis within the Borough with the principal office or primary place of employment located within the Borough. At least three of the five members of the Local Human Relations Commission must be residents of the Borough; and

WHEREAS, the Borough Council desires to appoint Jennie Dillon to the Local Human Relations Commission for an initial one (1) year term commencing on April 12, 2021 and expiring on the April 15, 2022; and

WHEREAS, the Borough Council desires to appoint Janelle Wertzberger to the Local Human Relations Commission for an initial two (2) year term commencing on April 12, 2021 and expiring on April 15, 2023; and

WHEREAS, the Borough Council desires to appoint Jay Eckman to the Local Human Relations Commission for an initial three (3) year term commencing on April 12, 2021 and expiring on April 15, 2024; and

WHEREAS, the Borough Council desires to appoint Taurean G. Moses to the Local Human Relations Commission for an initial four (4) year term commencing on April 12, 2021 and expiring on April 15, 2025; and

WHEREAS, the Borough Council desires to appoint Janet Morgan Riggs to the Local Human Relations Commission for an initial five (5) year term commencing on April 12, 2021 and expiring on April 15, 2026; and

WHEREAS, the Borough Council desires to appoint Scott Hancock as an alternate to the Local Human Relations Commission for a three (3) year term commencing on April 12, 2021 and expiring on April 15, 2024.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania hereby appoints Jennie Dillon to the Gettysburg Borough Human Relations Commission for an initial one (1) year term commencing on April 12, 2021 and expiring on April 15, 2022.

BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Janelle Wertzberger to the Gettysburg Borough Human Relations Commission for an initial two (2) year term commencing on April 12, 2021 and expiring on April 15, 2023.

BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Jay Eckman to the Gettysburg Borough Human Relations Commission for an initial three (3) year term commencing on April 12, 2021 and expiring on April 15, 2024.

BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Taurean G. Moses to the Gettysburg Borough Human Relations Commission for an initial four (4) year term commencing on April 12, 2021 and expiring on April 15, 2025.

BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Janet Morgan Riggs to the Gettysburg Borough Human Relations Commission for an initial five (5) year term commencing on April 12, 2021 and expiring on April 15, 2026.

BE IT FURTHER RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints Scott Hancock as an alternate to the Gettysburg Borough Local Human Relations Commission for a three (3) year term commencing on April 12, 2021 and expiring on April 15, 2024.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint members and alternate members to its Local Human Relations Commission pursuant to section 1-1307 of the Borough of Gettysburg Nondiscrimination and Local Human Relations Commission Ordinance.
