

**ORDINANCE NO. 1480-21**

**AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15, PART 10, SECTION 1003 AND SECTION 1010 OF THE CODE OF ORDINANCES OF THE BOROUGH OF GETTYSBURG, BY ADDING NEW SUBSECTION 4 FOR THE PURPOSES OF DESIGNATING CERTAIN AREAS ON RESIDENTIAL PARKING PERMIT STREETS AS PARKING SPACES FOR USE BY PERSONS WITH DISABILITIES AND TO PROVIDE FOR AN ADDITIONAL PENALTY PROVISION FOR VIOLATION OF THE ORDINANCE.**

The Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, hereby enacts, adopts and ordains this Ordinance amending Chapter 15, Part 10, Section 1003 and Section 1010 of the Code of Ordinances of the Borough of Gettysburg as follows:

**Part 10.  
RESIDENTIAL PARKING PERMIT SYSTEM**

**SECTION 1:** Chapter 15, Part 10, Section 1003, shall be amended by adding new subsection 4. in order to establish areas on residential parking permit streets to designate and reserve such areas as parking spaces for the exclusive use by persons with disabilities who are residents as defined herein in Section 1002:

**§ 15-1003. Designation.**

4. The following areas located on residential parking permit streets are hereby designated and reserved as parking spaces for the exclusive use by a person or persons with disabilities who reside on residential parking permit streets identified as follows:

<b>Street</b>	<b>Between</b>
West High Street (north side)	A point 48 feet 10 inches east of Franklin Street and a point 361 feet 6 inches west of South Washington Street (one parking space)
Liberty Street (east side)	A point 60 feet 2 inches south of York Street and a point 116 feet 1 inch north of East Zerfing Alley (one parking space)
West Water Street (south side)	A point 57 feet 7 inches west of Monument Alley and a point 65 feet 2 inches east of North Washington Street (one parking space)

The reserved parking spaces for exclusive use by a person or persons with disabilities shall be designated by appropriate signage. In addition to penalties for violations of this provision, vehicles unlawfully parked in a space reserved for a person or persons with disabilities may be subject to towing.

**SECTION 2:** Chapter 15, Part 10, Section 1010 shall be amended to add the following additional penalty provision:

**§ 15-1010. Penalties.**

\* \* \*

Any person violating the provisions and regulations in this Part by parking in a reserved area or space for exclusive use by a person or persons with disabilities is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of not less than \$50 nor more than \$200 as well as an additional fine of \$50.

**SECTION 3:** All remaining provisions of Chapter 15, Part 10 of the Code of Ordinances of the Borough of Gettysburg shall remain in full force and effect unless otherwise repealed by any other ordinance. All ordinances, or parts of ordinances, conflicting with this Ordinance shall be and the same are hereby repealed insofar as the same affect this Ordinance.

**SECTION 4:** This Ordinance shall take effect upon enactment.
