The Adams County Economic Development Corporation (ACEDC) was incorporated in 1960 as the Gettysburg Industrial Development Corporation. In 1989, the name of the organization was changed and ACEDC was born. ACEDC is a 501(c) organization whose mission is to improve the economy of Adams County while preserving and enhancing the quality of life by formulating, implementing and promoting economic development strategies for sustained investment and employment opportunities in Adams County.

The ACEDC is part of the Adams Economic Alliance which also includes the Adams County Industrial Development Authority and the Adams County General Authority. The Alliance's focus is business retention, expansion, attraction and workforce development. This is accomplished through low, fixed rate financing programs, training programs and a referral network of partners read to assist their business in reaching its full potential. Adams County Tax Collection Committee

Governor's Rural Development Council January Meeting

On January 7, 2019, the Rural Development Council (RDC) held their meeting at the Department of Agriculture building in Harrisburg. David Bolton, a RDC council member, reported that they recapped their activity over the past year. The highlights were:

- --Setting the Council's priorities of focus to Rural Broadband, Workforce Development/Career Training, Heroin/Opioid Epidemic, Regionalization of services, Healthcare accessibility.
- --RDC have been briefed by and exchanged ideas with: Health Secretary Rachel Levine, PEMA Director Richard Flinn, PA Fire Commissioner Bruce Trego, Secretary of Agriculture Russell Redding, Ag Deputy Secretary Mike Smith, Ag Deputy Secretary of Marketing Development Cheryl Cook, Deputy Secretary for Animal Health and Food Safety Greg Hostetter, Education Deputy Secretary David Volkmann, Deputy Health Secretary Lauren Hughes and others.
- --Since our reauthorization in 2015, the RDC had held discussion on: Broadband needs and solutions, promotion of the federal POWER initiative to help negatively affected area in the coal region, strategic planning and collection of feedback for PA agriculture, sustainability for rural hospitals and healthcare providers, promotion of USDA Rural Development programs, county issues and priorities working with CCAP (state board of county commissioners).

Going forward, the Council will continue to work towards these efforts. I have been a vocal participant in these meetings, presenting the perspective of PA Boroughs to the Governor's Cabinet and leaders from various federal departments in DC. I have stressed relief from unfunded state and federal mandates and have touted the community accomplishments from the York/Adams area especially as examples for others to follow.

Office of Open Records Issues New Standard Right-to-Know Law Request Form

PA Office of Open Records (OOR) is required by Pennsylvania's Right-to-Know Law to "develop a uniform [request] form which shall be accepted by all Commonwealth and local agencies" (Section 505(a) of the RTKL). In such, the OOR has issued a new version of the Standard RTKL Request Form, which is available at // https:www.openrecords.pa.gov/RTKL/Forms.cfm. The new Standard RTKL Request Form reflects great input from both agencies and requesters. The OOR asked for feedback in September and made changes based on that feedback.



As required by Section 505(a) of the RTKL, all Commonwealth and local agencies must accept RTKL requests submitted on the new Standard RTKL Request Form, as well as requests submitted on previous versions of the Standard RTKL Request Form.

PSAB Resolutions Deadline

Advocacy is important because it helps you to gain access to programs, funding, and education resources that can support your borough. Individual boroughs or County Boroughs Associations (CBAs) can submit a resolution at any time, as issues arise. You do not need to wait until the months leading up to the annual conference to submit a resolution, however, in order to be considered for formal adoption at the Annual Conference, resolutions do need to be submitted by April 10, 2019.

Community Media (CM) January Update: Community Media has been blessed to have so many municipalities answer the call for assistance after the Comcast funding pull-out, but more help is needed to fulfill CM's vision of service to the people of Adams County. New Tool to Report Suspicious Prescription Drug Activity

Gov. Tom Wolf and Attorney General Josh Shapiro announced the creation of a tool for reporting suspicious activity surrounding the prescribing or dispensing of prescription drugs, including opioids. The new tool is available at https://www.attorneygeneral.gov/rx/.

The Attorney General's Office of Diversion created the suspicious activity report form, a web-based form for health care providers and the general public to report suspicious activity involving prescription medication. The activity might include fraudulent, stolen, or altered prescriptions, a suspicious doctor or pharmacy, or an individual



obtaining prescription drugs for any purpose other than the treatment of an existing medical condition, such as for purposes of misuse, abuse, or diversion. Completed reports are assigned to the appropriate Attorney General's Office investigator in the region where the suspicious activity is alleged to have taken place.

While Pennsylvania has had a prescription drug monitoring program since the 1970s, it was in 2016 that Gov. Wolf announced the PDMP program would be run by the Department of Health. Those with an active Pennsylvania professional license that permits them to prescribe or dispense medications must register to use the PDMP. Authorized users include prescribers, dispensers, the Attorney General's Office (on behalf of law enforcement), designated commonwealth personnel, and medical examiners or county coroners.

More than 90,000 registrants have conducted approximately 1.6 million patient searches each month. The PDMP online database allows prescribers and dispensers of controlled substances to monitor who is obtaining opioids, who prescriptions are being obtained from, how often they are prescribed, and supports clinicians in identifying patients who may be struggling from the disease of addiction and help connect them with treatment services.

PennDOT Issues Guidance on Procurement of Traffic Signals Using Liquid Fuels Tax Funds

As the result of recent audit findings by the Department of the Auditor General concerning liquid fuels expenditures by municipalities for traffic signal maintenance services, the Department of Transportation (PennDOT), with the concurrence of the Auditor General, has issued guidance to assist your municipality in procuring these services going forward.

In short, these services need to be advertised and procured competitively in accordance with the applicable municipal code or relevant Penn DOT policies, and not as no-bid items. This information was mailed to each municipality by PennDOT. A copy is also available on PSAB's website, https://boroughs.org.

The Local Government Records Committee, authorized through the Municipal Records Act (53 Pa.C.S. 1381—1389), is proposing a new policy to allow municipalities to keep permanent records in electronic format and updating the existing electronic-records policy found in the Municipal Records Manual.
