SB 251 vs. HB 2148 Comparison

Senate Bill 251 passed the Senate by a vote of 46-3 on November 14, 2017, it is currently pending in the House Transportation Committee. However, House Representative Rothman has introduced House Bill 2148. Presently, both bills remain in the House Transportation Committee. The Radar Coalition, which consists of the PA Chiefs of Police Association; Fraternal Order of Police, State Lodge; PA Municipal League; Pennsylvania State Association of Boroughs; PA State Association of Township Commissioners; PA State Association of Township Supervisors; and PA State Mayors' Association, is hoping that the committee release SB 251 to the General Assembly for a vote. Input Sought on Bicycle and Pedestrian Master Plan

The Pennsylvania Bicycle and Pedestrian Master Plan seeks to outline a vision and framework for improving conditions for walking and bicycling across the state, with a focus on those who walk and bicycle by

necessity. The Master Plan will provide recommendations for improving the connectivity, safety, convenience, and use of the state's bicycle and pedestrian networks.

Additional goals of the Pennsylvania Bicycle and Pedestrian Master Plan goals include:

- Develop goals, objectives, and performance measures for biking and walking;
- Make additional program and policy recommendations beyond those made in the Pennsylvania Transportation Advisory Committee Bicycle and Pedestrian Study (TAC Study) to the State Transportation Commission (STC); and



Provide guidance on ways to improve local pedestrian and bicycle planning and design efforts.

Adams County Construction Permit Process

In the coming months the County is drafting and plans to adopt a resolution changing the process for county construction permits. Residents seeking a county permit will be required to show either a municipal permit or a signed letter from the municipality stating that a municipal permit was not required. While there will still be people conducting work without a county permit, we hope that this reduces the number. Likewise, this will reduce the number of residents failing to obtain municipal permits, due to their "belief" that a county permit sufficed. Once we have a draft, it will be released to the COG, so that their members receive copies in time for any comment. Also, any implementation date will be set far enough out to allow time for municipalities to incorporate this step with the permit process.

Adams County Transportation Planning Organization Update

The Adams County Transportation Planning Organization (ACTPO), in coordination with the Pennsylvania

Department of Transportation (PennDOT) is in the process of preparing the FFY 2019-2022 Transportation Improvement Program (TIP) for Adams County. The TIP lists priority highway, bridge, safety, transit, and enhancement projects for the period of October 1, 2018 through September 30, 2022. As part of the TIP development process, the 2019-2022 Adams County Transportation Improvement Program (TIP) will be available for public review and comment from May 16,



2018 to June 18, 2018. Additionally, ACTPO will hold two public information meetings on June 13, 2018 to present and receive comments on the 2019-2022 TIP. One meeting will be held at 11:00 a.m. A second meeting will be held at 7:00 p.m. Both meetings will be held at the Adams County Agricultural and Natural Resource Center at 670 Old Harrisburg Road, Gettysburg, PA.

The AORO database allows the public to contact the correct AORO to request agency records and ensures that the OOR can contact AOROs in the event an appeal is filed with the OOR.
