## COUNCIL MEETING MINUTES - NOVEMBER 14, 1983

The November Council meeting was called to order at 7:30 PM by President Shealer. All members of Council were present.

The minutes of the October Council meeting and of the Public Hearing held October 24, 1983 were approved as read.

President Shealer welcomed Boy Scout No. 73 who were observing Council proceedings.

Mayor Weikert reported he had received a request for establishment of a "Snow Emergency Route" on West Lincoln Avenue from a resident there. Following discussion Council felt the suggestion was not feasibile at this time.

President Shealer congratulated Mr. Heflin on his election for the office of Mayor also the other members who had successfully be re-elected.

Mrs. Romero reported the Utility Committee had made a survey of the borough rel to street lighting.

Moved Mrs. Romero seconded Mr. Cluck an additional street light be placed on an existing pole on the north side of West Broadway. Motion carried.

Moved Mr. Miller seconded Mr. Cluck the Borough paint "SCHOOL" on the roadway; erect "SCHOOL" signs; remove 7 parking meters and post "NO STOPPING OR STANDING" signs on West High Street as safety precautions for St. Francis students. Motion carried.

Moved Mr. Miller seconded Mr. Witt a crosswalk be placed on Baltimore Street between Holiday Inn and Sheetz store also another to be placed across Baltimore Street south of Breckenridge Street - 3 parking meters to be removed from east side of Baltimore Street. Motion carried.

The Safety Committee recommended the traffic patterns in Foth Alley remain unchanged.

Mrs. Daniels reported receipt of an additional \$500 from Mack Realty Co. to clean debris from Fahnestock Building.

Mrs. Daniels announced she has been named chairman of Beautification Committee for the Downtown Revitalization Project.

Mrs. Daniels suggestion to make a portion of Race Horse Alley one-way was discussed - no action taken.

Moved Mrs. Daniels seconded Mr. Madsen Council appoint Noel Stoffel to fill the unexpired term of David Johnson, who has moved from the Borough, on the Recreation Board. Mr. Stoffel's term to expire September 1985. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin all approved bills and payrolls be paid. Motion carried.

Moved Mr. Ditzler seconded Mr. Witt the Fire & Liability coverage from Nov. 1, 1983 thru June 30, 1984, cost \$1,471.00 be awarded to Hockley & O'Donnell. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the proposal of Hockley & O'Donnell to provide Police Professional Liability coverage, cost \$1,443.00 be accepted. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen Council tentatively adopt the 1984 Budget in the amount of \$989,731.00. Motion carried.

Letters to be sent State Legislators registering Council's opposition to pending legislation that would reduce speeding fines.

Russel Arkin told Council he expects to begin renovations on Fahnestock Building early in '84.

President Shealer named Mr. Miller, Mr. Sterner, and Sgt. Sistrunk to serve on the Eichelberger-Stahle Committee.

Mr. Sterner read Murphy Co. proposal for public metered parking lot. Council is not interested in their proposal.

Moved Mr. Witt seconded Mr. Madsen Council purchase 3 subscriptions to Pennsylvanian Magazine. Motion carried.

Moved Mr. Heflin seconded Mr. Cluck Council accept the resignation of James Behm from Borough Planning and Zoning Commission. Mr. Behm has moved from the Borough. Motion carried.

Moved Mr. Heflin seconded Mr. Madsen the reports of the Mayor, Chief of Police Treasurer and Code Enforcement Officer be approved. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the proposal of Carroll Zentz to erect a 32' x 70' one story building on vacant lot be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

The building proposal of the Dobbin House and sign proposal of Dr. John Dufendach were tabled until later.

Moved Mr. Ditzler seconded Mr. Cluck Council accept HARB Minutes. Motion carried.

Moved and seconded meeting adjourn at 8:50 PM. Motion carried.
