Moved and seconded June Minutes beapproved as written.

Mark Hess, Keystone Communicable, briefed Council on progress of the rebuilding of the cable system.

Lon Gore reported construction on Hotel Building will begin in two weeks.

Moved Mr. Ditzler seconded Mr. Hartzell Ptl. Kevin Wilson be given permanent status on the police force, effective July 17, 1984. Motion carried.

Mr. Ditzler reported 20 persons took recent Civil Service exam.

- 2. Borough Manager to locate site on property
- 3. Borough crews will dig the hole
- 4. Property owners who plant trees will be subsidized by Borough in the amount of \$5.00 per tree

Moved Mr. Delzingaro seconded Mr. Schmitt Council approve the Amendment to the Historic District Ordinance to permit variances for height limitations. Motion carried.

Mr. Delzingaro reported the Rec Board members in favor of Borough taking charge of maintenance of park. A recent problem caused by an overloaded transformer at the Rec Park was corrected by replacement of transformer with one obtained from Gettysburg College.
