MINUTES OF MEETING - OCTOBER 8, 1984

President Shealer presided at the October meeting of Council. Council members present included Messrs. Linn, Hartzell, Schmitt, Delzingaro, Mrs. Daniels, Messrs. Madsen. Witt. and Ditzler.

The minutes of the September 10th meeting and of the Special Meeting held September 13th were approved as prepared.

Mrs. Smith, resident of the Majestic Apartment Building, reported some progress in correction of problems in the building.

Mayor Heflin announced the Halloween Parade will be held October 23rd, rain date October 24th. Trick or Treat for youngsters up to and including 6th grade will be held October 25th from 6:30 to 8:00 PM.

Moved Mrs. Daniels seconded Mr. Delzingaro Council approve the following resolution: "Resolved, that the Council of the Borough of Gettysburg in recognition of thirty-six years of outstanding service to our community as secretary-treasurer of Gettysburg Municipal Authority, do hereby express our sincere appreciation to George T. Raffensperger." Motion carried.

Utility Committee to study a request for an additional light on North Stratton Street. Mrs. Daniels had received the request.

Mrs. Daniels reported she attended a recent meeting of Adams County Planning Commission rel to establishment of a county-wide solid waste program as mandated by Act 97. Additional information will be forthcoming.

Mrs. Daniels suggested that when emergency signs prohibiting parking are erected they should state a definite time when vehicles must be moved. During the discussion Chief Potter reported that practice had been used in the past with little or no appreciable difference in the number of offenders.

Moved Mr. Madsen seconded Mr. Witt all approved bills and payrolls be paid. Motion carried.

Mr. Witt reported he and Mrs. Daniels had met with the Dean of Students and a group of college students rel to parking problems in vicinity of the college.

Safety committee to study Mrs. Daniels proposal to erect a "Patient Loading/Un-loading" sign on East High Street for Drs. Wood and Beckman. A motion to that effect did not receive a second - motion died.

Motion Mr. Ditzler seconded Mr. Hartzell the first meter, east of the Borough parking lot on the north side of East Middle Street, be removed. Motion carried.

Mr. Ditzler moved and Mr. Schmitt seconded the cross walk recently placed on Baltimore Street, near Breckenridge Street remain intact. Motion carried by majority vote, Mrs. Daniels, Mr. Witt, Mr. Delzingaro dissenting.

Moved Mr. Ditzler seconded Mr. Schmitt a "School" sign be placed on Baltimore Street north of Wade Avenue. Motion carried.

Moved Mr. Ditzler seconded Mr. Witt "No Trucks" signs be erected on North Fourth from East Water Street north to Harrisburg Street. Motion carried.

Mrs. Daniels, Mr. Witt, Mr. Sterner, Chief Potter to meet with Dr. Glassick rel to college parking problems.

Mr. Ditzler reported 10 MPH Speed Limit signs will be erected in Rec Park.

Moved Mr. Ditzler seconded Mr. Schmitt the cost of parking fines be doubled, eff-January 1, 1985. Motion carried.

Moved Mr. Ditzler seconded Mr. Hartzell that parking be removed from the west side of Reynolds Avenue between Springs Avenue and West Middle Street; extend the yellow line seventy-five feet south of Wolf Alley on the east side of Reynolds Avenue. Motion carried.

Mr. Ditzler cited the safety hazard that exists during sidewalk construction when pedestrians walk out into the street. The discussion following determined that at the present time there is nothing on record to discourage this practice but with the adoption of the proposed BOCA Codes the situation will be controlled by issuance of permits.

Mr. Linn reported he and Mr. Ditzler had toured the highway maintenance building and found Borough in need of some equipment.

Moved Mr. Ditzler seconded Mr. Madsen the treasurer be authorized to transfer the 2% tax on foreign insurance premiums, in the amount of \$34,150.60, to the Police Pension Fund. Motion carried.

Finance Committee to study proposals received for traffic survey.

Highway and Property Committees to consider cost of repairing sweeper and make recommendations.

Mr. Oyler to contact Keystone Sanitation Company's legal firm for further information re imposing of a tax by the township in which landfill is located.

Mr. Sterner reported a Public Hearing for Revenue Sharing Funds will be held October 29, 1984 at 7:00 PM. Following the hearing the committees will hold a budget meeting.

The November meeting of Council will be held Tuesday, November 13, 1984, at 7:30 PM.

Moved Mr. Hartzell seconded Mr. Linn the needed funds be appropriated for Mr. Lawver to attend a seminar in Allentown - October 24, 25, 26. Motion carried.

Mr. Lawver as Borough Fire Marshall will be attending meetings on October 18th and 22nd.

Moved Mr. Ditzler seconded Mr. Schmitt the reports of the Mayor, Police Chief, Treasurer, and Code Enforcement Officer be approved. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen the sign proposal of Dr. Drum and Leonard Ferraro be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Ditzler seconded Mrs. Daniels the proposal of American Legion be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen HARB Minutes be approved. Motion carried.

Moved and seconded meeting adjourn at 9:50 PM. Motion carried.
