

MINUTES OF MEETING HELD APRIL 8, 1985

The April meeting of Council was called to order at 7:30 PM by President Shealer. Council members attending: Mrs. Daniels, Messrs. Ditzler, Madsen, Hartzell, Schmitt, Linn, Witt, Delzingaro.

The Minutes of the March meeting were approved as presented.

Motion Mr. Hartzell seconded Mr. Daniels Mr. Henry Ordemann be named General Chairman of a bicentennial committee and he be authorized to form appropriate committees. Dr. Glatfelter and Jackie White expressed a willingness to assist in planning events to commemorate the 200th anniversary of the town. Motion carried.

Florence Saltzer, Jack Corbin and Charles Kuhn, recipients of sidewalk notices, registered their complaints and Mr. Corbin questioned the Borough's practice of sending notices by certified mail and the criteria used in determining which notices were to be issued. Mrs. Daniels explained the procedures used in preparing the list from which the notices are sent.

Moved Mr. Ditzler seconded Mr. Madsen Council approve the HARB recommendation to issue HG-AC Inc. a demolition permit for the pre-Civil War cabin at 201 South Washington Street; HG-AC Inc. has extensively researched the building and have not found any evidence of the building having any historic value and in its present condition presents a safety hazard. If HG-AC Inc sells the property this approval would enable the prospective buyer to remove the cabin. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen Council approve HARB Minutes. Motion carried.

Moved Mr. Madsen seconded Mrs. Daniels that the request of the Hospital Auxiliary be granted and issue them a permit to present a fireworks display on May 25 (rain date 26th) at Rec Park. Motion carried.

Moved Mr. Hartzell seconded Mr. Linn the proposal of Hartzell Fence Company, \$1,799.00 be accepted to enlarge the Borough Councpound. Motion carried.

Moved Mr. Linn seconded Mr. Hartzell Robert Mitton be appointed to the Rec Board to fill the unexpired term of Jane Nutter. Mr. Mitton's term to expire September 1986. Motion carried.

Moved Mr. Schmitt seconded Mr. Madsen Helen Bream be appointed to fill the unexpired term of Carl Payden on the Borough Planning & Zoning Commission. Term to expire December 1988. Motion carried.

Mr. Ditzler reporting on recent Safety Committee meeting:

1. Determined a crosswalk at N. Stratton & East Lincoln Avenue unwarranted.
2. Ptlm. Runk graduates from State Police Academy April 19, 1985.

Moved Mr. Madsen seconded Mr. Delzingaro all approved bills and payrolls be paid. Motion carried.

Mr. Schmitt will be Borough representative on Civic Betterment Committee. Meetings are held 3rd Tuesday at noon.

Mrs. Daniels reported two sites are being used in the Community Garden Project, Johns Avenue and between Carlisle St and N. Stratton St.

Mrs. Daniels, served as a stand-in for Mr. Hartzell-Council's appointed representative, at a recent meeting of the Solid Waste Advisory Committee. This Committee will be working on a county-wide plan.

Moved Mrs. Daniels seconded Mr. Schmitt the curb repair list for work along streets scheduled for 1985 road projects be approved and notices sent. Motion carried.
