

MINUTES - JUNE 10, 1985

Vice President Witt called the meeting to order at 7:30 PM. The meeting was attended by the following councilmembers: Mrs. Daniels, Mr. Madsen, Ditzler, Delzingaro, Schmitt, Hartzell and Linn.

The minutes of the May meeting were approved as prepared.

Mark Hess and Randy Williams from West Shore TV Cable were present in response to Council's invitation. Mr. Hess reported the majority of the problems generated when the new system was activated have been resolved. The establishment of a local office is not feasible at this time but the possibility of one in the future has not been ruled out definitely. Monthly service bills can be paid at any of the Gettysburg National Bank offices.

Moved Mr. Hartzell seconded Mr. Madsen an ordinance be drawn requiring all cats and dogs within the Borough to be licensed, innoculated, and leashed, if off their owners premises, to protect the health of our citizenry. Motion carried by majority vote 4 to 3. Ayes - Madsen, Hartzell, Schmitt, Ditzler
Nays - Linn, Delzingaro, Daniels

Mrs. Daniels reported on the recent meeting of Adams County Solid Waste Advisory Committee at which time it was reported the proposed Hanover incinerator is one proposal under consideration. Borough Manager to keep Council posted of future meeting dates.

Borough Manager to get cost estimates for handicapped ramps on Lincoln Square.

Mrs. Daniels reported she had recently attended a seminar at Penn State on tree planting.

Mrs. Daniels reported the sidewalk committee is preparing a listing of the policies and procedures used to determine the need for repair and/or replacement of walks. It was reported Council will be placing a sidewalk along the Rec Park over the next several years.

Moved Mr. Madsen seconded Mr. Schmitt all approved bills and payrolls be paid. Motion carried.

Moved Mr. Madsen seconded Mr. Schmitt Council approve the exoneration list as presented by G. H. Harris Associates after the removal of Beverly Beard's name from the list. Motion carried.

Mr. Madsen reported the Board of Directors of Adams County Earned Income Tax Collection Agency have approved a 5% salary increase for the employees.

Mr. Sterner's report:

1. Pennington Tree Service has sprayed the trees on Lincoln Square at no cost to the Borough
2. Finance Committee and Mr. Sterner to meet with representatives of non-uniform pension plan on June 19th - 1:30 PM.
3. The grant to provide funding for Fahnestock Building and Rec Park Restroom facilities (1984) looks favorable. In September another application should be submitted for 1985 funds.
4. Proposed Zoning changes require public hearing be held prior to being included in recodification. Hearing scheduled for 7 PM, July 8, 1985, prior to Council meeting.
5. A storm sewer is being placed in Colt Park area.
6. Painting of curbs and crosswalks complete.
7. Roy Hardman property at 135 West Street has an accumulation of raw sewage in basement. He has been notified he is in violation of the nuisance ordinance. If he fails to comply within 15 days the Boro will take

care of the situation and bill him.

Code Enforcement Officer:

1. Investigated garbage complaints
2. Dr. Lefever's fence will be completed by end of the month
3. Travelodge will probably comply but may ask for an extension of time.
4. Sidewalks will be placed at the two new homes on North Fourth Street.
5. Investigating possible gas leak on North Washington Street as a result of reported odor of gas fumes in the houses

Moved Mrs. Daniels seconded Mr. Schmitt the sign proposal of Jane's Styling Salon be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen the sign proposal of McCoy Companies be approved and a certificate of appropriateness issued as HARB recommended. Motion carried.

Moved Mrs. Daniels seconded Mr. Schmitt the sign proposal of Snelling & Snelling be approved and a certificate of appropriateness issued as HARB recommended. Motion carried.

Moved Mr. Madsen seconded Mr. Linn the sign proposal of Peoples Drug Store (Rea and Derick) be approved as HARB recommended. A certificate of appropriateness to be issued. Motion carried.

Moved Mr. Hartzell seconded Mr. Schmitt Council reluctantly approve the vague sketching presented as a sign proposal for the Wade House. HARB had approved the proposal. A certificate of appropriateness to be issued. Motion carried.

Moved Mr. Ditzler seconded Mr. Hartzell Council approve the reports of the Mayor, Police Chief, Treasurer, Code Enforcement Officer, Fire Department and the Minutes of HARB Meeting. Motion carried.

Attorney Oyler will send a letter on Council's behalf to U. S. Senators and Congressman Goodling opposing the proposed restrictions on municipal bonds.

Moved and seconded meeting adjourn at 9:25 PM. Motion carried.
