

COUNCIL MEETING
MARCH 12, 1990

Mr. Ditzler called the meeting to order at 7:30 P.M. with all of Council Present except for Mr. Stokes. Also present was Mayor Linn, Mr. Oyler, Mr. Sterner, Mr. Lawver, and Mr. Weikert. Those citizens attending the meeting include Dawn Williams, Susan Trostle, Kim Alexander from WGET Radio Station, Pete Menedis, Steve Wentz from Meridian Bank, Bill Walker, and Tammy Myers of the Wax Museum.

Moved and seconded the Agenda be approved. Motion Carried.

Moved and seconded the Minutes of the February meeting be approved. Motion Carried.

Walt Powell discussed the submission of the 1990 Community Development Block Grant application which is due May 30th. A Public Hearing is scheduled for Monday, April 9, 1990 at 7:00 P.M. to receive comments from interested persons.

Moved Mr. Frazee, seconded Mr. Songer:

A. That, subject to approval of the Safety Committee, the Parking Manager is authorized to establish and manage a program of token utilization for the parking meters on Lincoln Square, the first block of each street radiating from the Square, and the second block of Baltimore Street; tokens to be of 25 cent value and available for sale to merchants and others at that price;

B. That parking meter rates and hours of enforcement be set, for short term and long term meters, in accordance with the attached proposed press release;

C. That fines for meter violations be set at \$8.00, reduced to \$4.00 if paid within 24 hours, and increased to \$20.00 if not paid within 7 days; and

D. The Borough Solicitor is requested to prepare such legislation as necessary to make the foregoing effective, including amendments to present ordinances; the effective date as soon as possible.

Motion carried.

Moved Mr. Schmitt, seconded Mr. Frazee to purchase a 1983 pickup truck from Phiel at a cost of \$2,995.00. Motion Carried.

Moved Mr. Songer, seconded Mr. Schmitt to appoint William Little as the Parking Manager at a salary of \$20,000, with a six month probationary period. Motion Carried.

Moved Mr. Songer, seconded Mr. Frazee to accept the Audit Report. Motion Carried.

Moved Mr. Songer, seconded Mrs. Simpson to pay all bills and payrolls. Motion Carried.

Moved Mrs. Simpson, seconded Mr. Schmitt to accept the bids for concrete, stone, blacktop and equipment as follows: Motion Carried.

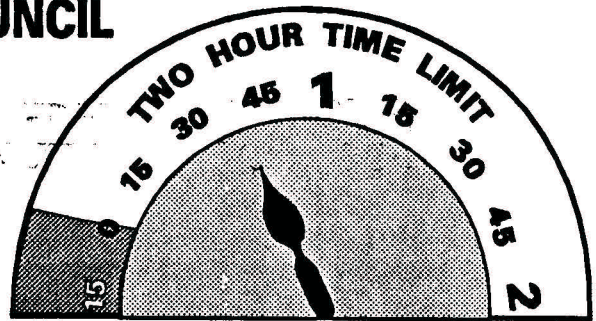


A quarter convenience slot is available.

FREE time.






Rates are in effect 6 days per week, 8 a.m. to 9 p.m. No charge on Sundays or holidays.

LONG-TERM (DAILY) RATES:



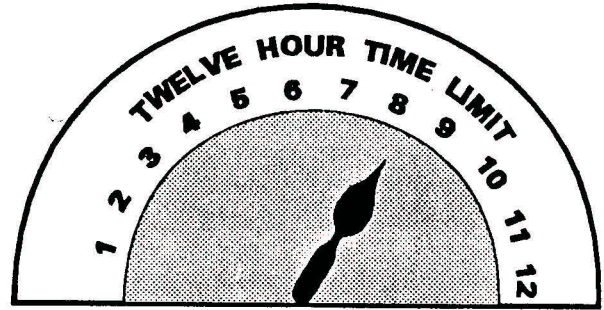
Long-term meters allow a maximum of 12 hours of parking.
