### COUNCIL MEETING

## SEPTEMBER 10, 1990

President Stokes called the meeting to order at 7:30 P.M. with all of council present. Also present included Mayor Linn, Mr. Ralph Oyler, Mr. Sterner, Mr. Lawver, Mr. Weikert, Mr. Little, Dr. Powell, Mary Francis Donnelly representing Gettysburg College, and Eric Persson.

Citizens in attendance included Paul Ketterman - President of the Lincoln Fellowship of Pa, Jennifer Mitchel - Leon Representative, Carl Mattson - Gettysburg College, Barbara Hartman, Art Stabler and Kathryn Gitt Schultz.

Moved and seconded the agenda be approved. Motion Carried.

Moved and seconded the minutes for August and the Special Meeting be approved. Motion Carried.

Mr. Stokes will be attending the PSAB Conference in Seven Springs on October 26-28. Council approved to pay expenses for the workshop not to exceed \$250.00.

Moved Mrs. Daniels, seconded Mr. Witt to appoint Gerald Miller as the Local Census Review Liaison. Motion Carried.

Paul Ketterman requested Council approval to place a bronze statue of Abraham Lincoln on Lincoln Square. Lincoln Fellowship will be raising funds for the project. Mr. Ketterman also requested Borough funds, such as the installation of the concrete base, towards the cost of the statue. Concerns of Council include:

- 1. Proposal must be approved by HARB.
- 2. Cost of base unknown.
- 3. Who would pay for the maintenance?
- 4. Council will not make firm commitment until approved by the other Boards.

Moved Mr. Schmitt, seconded Mr. Songer to approve placing the Abraham Lincoln Statue on the square, subject to Lincoln Fellowship obtaining all other necessary approvals as applies. Motion carried.

Carl Mattson, of Gettysburg College, introduced Jennifer Mitchel as the Leon Representative. Also thanked Council for the Resolution presented for Sister City Week, Sept. 9-16.

Moved Mrs. Daniels, seconded Mr. Frazee to adopt the resolution commending Art Stabler for his 18 years of service with HARB. Motion Carried.

Moved Mrs. Daniels, seconded Mr. Schmitt to approve HARB "consent agenda". Motion Carried.

Moved Mrs. Daniels, seconded Mr. Schmitt to approve the reallocation of the 1985 CDBG funds and to modify the 1988 CDBG budgets as follows: Motion Carried.

## CDBG Fiscal Year 1985:

- 1. Reallocate \$6,687.20 for the following activities:
  - a. \$2,608.55 for the YWCA to run a "Senior Citizens Fitness Program."
  - b. \$4,078.65 for "Acquisition/Relocation" to assist in completing the purchase of 53 Breckenridge Street, to be used in the Homeownership Program.

## CDBG Fiscal Year 1988:

 Move \$3,866 from "Housing Rehabilitation--Third Ward" to "Public Services--YWCA Senior Citizens Fitness Program."

Moved Mr. Witt, seconded Mr. Schmitt to adopt the Resolution for Code of Conduct. Motion Carried.

Mr. Ditzler reported for the Safety Committee stating that the proposed ordinance for the prohibiting of human powered vehicles on sidewalks will be referred back to the committee.

Moved Mr. Witt, seconded Mr. Schmitt to adopt an Ordinance making it unlawful to park between the hours of 2 o'clock A.M. and 6 o'clock A.M. on the south side of West Lincoln Avenue and on both sides of West Broadway between College Avenue and Constitution Avenue. Motion Carried.

Moved Mr. Witt, seconded Mr. Schmitt to adopt an Ordinance fixing the cost of Parking Tokens at 20 cents each, Motion Carried.

The ordinance to provide for a left turn lane on Lefever Street at the intersection with Baltimore Street was tabled for further study.

Moved Mr. Witt, seconded Mr. Schmitt to adopt an Ordinance establishing a Parking Garage for the Borough: providing rates of such garage: and providing penalties for violations. Motion Carried.

Mrs. Daniels reported that the Tree Committee will be meeting on September 13 at 3:00 pm.

Moved Mrs. Daniels, seconded Mr. Schmitt to reappoint William Hutchison as of July to the Gettysburg Area Industrial Development Authority. This term is for 5 years and will expire in July 1995. Motion Carried.

Moyed Mrs. Daniels, seconded Mrs. Simpson to reappoint Frank V. Herman to the Recreation Board for a 5 year term ending in September 1995. Motion Carried.

Moved Mrs. Daniels, seconded Mr. Songer to reappoint Kathryn G. Schultz to HARB for another 5 year term ending in August 1995. Motion Carried.

Moved Mrs. Daniels, seconded Mr. Frazee to appoint Gary W. Shaffer to HARB for a 5 year term ending in August 1995. This position will replace Art Stabler. Motion Carried.

Mrs. Simpson, Highway Committee, reported that leaves and brush will be picked up beginning on or about October 1.

Moved Mr. Songer, seconded Mrs. Simpson to pay all bills and payrolls. Motion Carried.

Moved Mr. Schmitt, seconded Mrs. Simpson to enter into a Sister City Relationship with Gettysburg, South Dakota. Motion Carried.

## Managers report:

- October and November Council Meetings will be held on Tuesday due to Holidays.
- 2. Salary Board must meet as a first step in budget preparation.
- 3. No bids were received for the scooter.
- 4. Parking Garage will open on Tuesday September 11 at 6:00 AM with free parking until September 22. The Grand Opening Ceremony will take place on Friday September 21 from 5:00 to 7:00 PM.

Chief Gantz reported that Officer Warren Sheppard has submitted his resignation from the Police Department. Civil Service procedure begun to hire a new officer.

### Mr. Lawver reported:

- 1. The new dump truck has been delivered.
- 2. All utility work in Race Horse Alley will be complete prior to September 21.

Ms. Weaver reported that the Adams County Boroughs Association will be meeting at the Farnsworth House on September 17 at 6:30 PM.

Moved Mr. Ditzler, seconded Mr. Songer to approve the reports of the Mayor, Treasurer, Chief of Police, Code Enforcement Officer and Parking Department. Motion Carried.

## RESOLUTION

The Borough of Gettysburg hereby establishes a written Code or Standards of Conduct governing the performance of any person who is an employee, agent, consultant, or officer (elected or appointed) of the Borough of Gettysburg engaged in the award and administration of any contract. The following written policy shall be enforced:

- 1. No employee, agent, consultant, or officer, of the Borough of Gettysburg shall participate either in the selection or in the award and administration of a contract, subcontract or an agreement for supplies, equipment, construction or services if a conflict of interest, real or apparent, would be involved. Such a conflict would arise when:
  - a. the employee, officer, agent, solicitor or general consultant;
  - b. any member of his or her immediate family;
  - c. his or her partner; or
  - d. an organization which employs, has employed, or is about to employ any of the above,

has a financial or other interest in the firm selected for award. This prohibition extends for a period of one year after an employee, officer or agent leaves his or her position with the Borough of Gettysburg.

2. No employee, officer, or agent of the Borough of Gettysburg shall either solicit or accept gratuities, favors, entertainment, or anything of significant monetary value from contractors, potential contractors or parties to sub-agreements.

### RESOLUTION--2

- 3. Officers, employees, agents, contractors or their agents who violate these standards of conduct are subject to the penalties, sanctions, or disciplinary action by the Borough of Gettysburg to the extent permitted by State and local laws or regulations.
- 4. Any contractor who benefits from any violation of the above sections shall be declared to be in breach of contract by the Mayor and Borough Council of the Borough of Gettysburg, and shall be subject to immediate termination of the contract.
- 5. Contractors deemed ineligible for work as determined by the Secretary of Labor, U.S. Department of Labor, shall not be hired, contracted or be allowed to participate in procurement or contracting transactions handled by the Borough of Gettysburg.

The above resolution is hereby adopted by a unanimous vote of the Gettysburg Borough Council at its regular monthly meeting held in Council Chambers on 10 September 1990.
