## COUNCIL MEETING NOVEMBER 13, 1990

President Stokes called the meeting to order at 7:30 pm with all of Council present. Also in attendance: Mayor Linn, Chief Gantz, Mr. Oyler, Mr. Lawver, Mr. Little, Mr. Weikert, and Dr. Powell.

Citizens in attendance included Bill Walker and Maria Malone of Gettysburg College; Randy Hartlaub, Brian Hartlaub and Terry Staub of Boy Scout Troop #78; Rick Goderi, Ruth Naugle, John Roth and Bob Sheads along with several other residents of Barlow Street; and Jonathan Hart.

Moved and seconded the agenda be approved. Motion Carried.

Moved and seconded the minutes for October be approved. Motion Carried.

Mr. Stokes noted that on Thursday, November 15, 1990 at 1:30 pm a meeting will be held in the old courtroom pertaining to the County Comprehensive Plan.

Randy Hartlaub, stroop master of #78, introduced two Boy Scouts who are here working on their merit badge.

Rick Codori, spokesman for the residents of Barlow Street, informed Council; that they are very upset with college students parking along the streets leaving no space for theoresidents. They would like Barlow Street to be included in the Residential Permit Parking Program.

Maria Malone, a student at Gettysburg College, is circulating a petition not to destroy the Travel Lodge parking area. She feels the College has a parking problem because walking from the parking lots to Carlisle Street at night is dangerous. Bill Walker will relay the concerns of Council to the College concerning the issue of the Travel Lodge parking (Paxton Hall).

Mr. Stokes reported that Council will consider the request of the Barlow Street residents being added to the RPP Program. It cannot be added at this time as the Ordinance requires a six month trial period which was adopted on August 13, 1990.

Mayor Linn questioned if free parking would be available at Christmas Time for shoppers.

Mr. Little reported that most county and merchant employees are the ones parking free - not the shoppers during the Holiday. After much discussion, Council recommends the merchants should use the tokens for free parking for holiday shoppers.

Moved Mr. Witt, seconded Mr. Schmitt to approve the Reallocation of \$57,640 from the 1990 Community Development Block Grant Program as proposed by Walt Powell. Motion Carried.

Mrs. Daniels - Health Committee reported sewage problems to GMA. The response from GMA indicated they were aware of the I and I problems and are working on each as time and funds permit.

Mrs. Daniels noted a Health Committee meeting will be held Monday, November 19, at 9:00 am to discuss recycling.

Moved Mrs. Daniels, seconded Mr. Schmitt to nominate Jane Parker to the Shade Tree Commission for a (4) four year term to replace Charlotte Armster. Motion Carried.

Mr. Ditzler reported for the Safety Committee about the parking Meter changes on Steinwehr Avenue. Need to amend the Parking Ordinance which was referred back to the Parking Committee.

Moved Mr. Songer, seconded Mr. Schmitt to pay all bills and payrolls. Motion Carried

Moved Mr. Songer, seconded Mr. Ditzler to approve the 1990 Proposed Budget and advertise same for public review. Motion Carried.

Moved Mr. Songer, seconded Mrs. Daniels to instruct Mr. Sterner to draft a job description to create a position for a Historic Preservation Officer, Small Grants Coordinator and Code Enforcement. Motion Carried.

Mr. Songer reported that resumes are being received for the a Recreation Director. Each will be reviewed and hope to report to a Council at the December meeting.

Mr. Songer noted that the Gettysburg High School Key Club will be sleeping on the square as a demonstration for the homeless. Anyone interested in making a pledge is welcomed.

Mrs. Simpson noted that the Highway Committee will meet on Wednesday, November 28, 1990 at 10:00 am.

Moved Mr. DeHaas, seconded Mrs. Simpson to approve the Flea Market Dates of May 18, 1991 and September 28, 1991. Motion Carried.

Moved Mr. Ditzler, seconded Mr. Schmitt to approve the cost of living increase for retired chief of police Potter's pension to become effective on October 1, 1990. Motion Carried.

Moved Mr. Schmitt, seconded Mr. Frazee to approve the deposit of \$64,044.67 received from Act 205 Pension Payments from the State. \$30,000 to Police Pension Fund and \$34,044.67 to Nonuniformed Pension Fund. Motion Carried.

Moved Mr. Schmitt, seconded Mrs. Simpson to approve advertising for the Square Bids to be opened at the January Council meeting. Motion Carried.

Mr. Stokes appointed Jean Simpson, Charles Sterner and Roosevelt Sistrunk to the Eichelburger/Stahle Committee.

Mr. Little reported the Parking Department will conduct a public hearing on November 25th for RPP.

Mr. Weikert reported that the Fire Prevention code is about ready for advertisement and should be adopted in January.

Moved Mr. Frazee, seconded Mr. Schmitt to approve the subdivision proposed by Gettysburg College along Constitutuion Avenue.

Moved Mr. Ditzler, seconded Mrs. Simpson to approve the subdivision for Habitat for Humanity/Homeownership at 152 Breckinridge Street. Motion Carried.

Chief Gantz reported on the recent International Chief's seminar he attended in Tulsa.

Moved Mr. Schmitt, seconded Mrs. Simpson to approve the reports of the Treasurer, Chief of Police, Code Enforcement Officer, and Parking Department. Motion Carried.

Moved Mrs. Daniels, seconded Mr. Schmitt to approve HARB "consent agenda". Motion Carried.

Mr. Songer noted that Code Enforcement must check into #4 of HARB on the Zoning regulations.

Moved to adjourn at 9:20 pm.
