The April meeting of Council was called to order by President Hull with the following Councilmen attending: Messrs. Weikert, Heflin, Little, Shealer, Musselman, Rebert, Thomas and Ditzler.

The minutes of the previous meeting were approved as read.

Mrs. Manley Potter appeared before Council to inquire about holding flea markets on the parking lot at the Greyhound Terminal on weekends during the summer. Council pointed out she would be responsible for policing and cleaning up the area.

Cyrus Bucher spoke on activities of the Community Action Agency and asked Council to consider ear-marking some of the Revenue Sharing Funds for use by the Agency if needed for some future project.

Mr. Ditzler announced the State had rejected the ordinance ordaining Village Drive and unless the engineers description was included liquid fuel money would not be paid for the street.

Moved Mr. Thomas seconded Mr. Weikert the Ordinance reordaining Village Drive, describing the street by metes and bounds, be adopted. Motion carried.

Mr. Ditzler reported the garbage ordinance is being rewritten. After some discussion the proposed ordinance dealing with the penalties was tabled until next month.

Moved Mr. Thomas seconded Mr. Little that approximately 200 ft of the Tiber floor south of West High Street be cemented. Motion carried.

Moved Mr. Thomas seconded Mr. Weikert that 600 ft of storm sewer on Buford Avenue from Elm Street west to North Hay Street be placed. The State will furnish the pipe, the only cost to the Borough being the installation. Revenue Sharing Funds will be used to place 250 ft 12^m storm sewer on Hay Street south of Buford Avenue. Motion carried.

Following the discussion rel to the need for a traffic signal at the Steinwehr Avenue-South Washington Street intersection Mr. Thomas made a mation seconded by Mr. Weikert that an application for a traffic signal be made to the State. The closeness of the vote prompted the President to call for a show of hands which resulted in a tie. (4 to 4). The President voted against the motion. Motion defeated.

Moved Mr. Rebert seconded Mr. Little the Borough rent a chipper to remove limbs and brush. Dates to be advertised in local newspaper. Motion carried.

Mr. Shealer recommended the Highway Department be commended for their work following the recent wind storm.

Mr. Weikert reported the Planning and Zoning Commission will hold the first public meeting on the proposed Zoning Ordinance on May 5, 1975 at 8 P.M. in the Court House. All Councilmen are urged to attend.

Moved Mr. Weikert seconded Mr. Heflin all approved bills and payrolls be paid. Motion carried.

Moved Mr. Weikert seconded Mr. Thomas the bill of \$22.40, the Sheriff's expenses in trying to locate Glenn Wallick, be paid. Motion carried.

Mr. Weikert reported receipt of the 3rd quarter Revenue Sharing check in the amount of \$18,165.00.

Moved Mr. Little seconded Mr. Rebert the bid of McDermitt, Inc. to supply

concrete as listed be accepted. Motion carried.

Mayor Lightner announced the resignation of Mrs. Margaret Lorenz.

Moved Mr. Shealer seconded Mr. Weikert the Borough adopt a resolution protesting the removal of the Reading Railway line s from the County. Motion carried.

Moved and seconded the reports of the Treasurer, Mayor, Police Chief, Fire Marshall, Gettysburg Historical District Architectural Review Board be accepted. Motion carried.

Moved Mr. Weikert seconded Mr. Rebert the sign application for the Mary Carter Paint Store be approved as recommended. Motion carried.

Moved Mr. Thomas seconded Mr. Weikert the sign application of Dr. W. Scott Mountain, Jr., Family Planning Agency for Adams County and C. B. Cellar be approved as recommended by the Gettysburg Historical District Architectural Review Board. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin three property owners, namely, Mrs. Kathryn Basehoar, Kathleen Mitchell and Mrs. Walter Hoffman, be sent notices to replace curbs on Breckenridge Street. Motion carried.

Moved Mr. Musselman seconded Mr. Ditzler that the Borough place a curb along the property of Jay Johnson on Hays street and bill him for the work. Mr. Johnson was notified January 24, 1975. Motion carried.

Moved and seconded meeting adjourn. Motion carried.
