COUNCIL MEETING MINUTES DECEMBER 13. 1993

President Simpson called the meeting to order at 7:30 PM with the following Council persons present: Mr. Ditzler, Mrs. Rice, Mr. Zellner, Mr. Troxell, Mrs. Gustafson, Ms. Giles, and Mr. Schmitt. Mr. DeHaas was absent. Also in attendance were Mayor Linn, Chief Gantz, Donald Oyler, Manager Sterner, Mr. Lawver, Mr. Weikert, Dr. Powell, Mr. Little and Mr. Persson. Representing the press: Lucy Basalla of the Gettysburg Times and Sharon Hare of the Hanover Evening Sun.

Moved Mr. Ditzler, seconded Mr. Schmitt to approve the agenda as presented. Motion carried.

Moved Mr. Ditzler, seconded Mr. Schmitt to approve the public hearing minutes of November 8 as presented. Motion carried.

Moved Mr. Ditzler, seconded Mr. Schmitt to approve the minutes of November 8 as presented. Motion carried.

Mrs. Simpson recognized Mr. Ditzler for his 20 years of service to the Borough as a councilman from the Third Ward.

Citizens in attendance:

John Murphy, newly elected Council person, thanked Mr. Ditzler for his community service.

Bill Walker, representing the college invited Council members to a breakfast on January 5th at 7:30 AM to be held at the Gettysburg Hotel.

Raye Ann Passmore, Carlisle Street, Jean McCrorie, 248 York Street, Alice Snyder, 217 Baltimore Street, and John Muller Stratton Street, attended to observe the meeting.

Bicky Redman, County Solid Waste Coordinator, gave a short presentation on the proposals for the county solid waste facility.

Moved Ms. Giles, seconded Mr. Schmitt to adopt an ordinance repealing the residential parking permit designation from a portion of Barlow Street. Motion carried.

Mr. Troxell reported that he will need to arrange another date with Mr. Weikert and Mrs. Gustafson another to complete the inspection of sidewalks.

Moved Mr. Troxell, seconded Mr. Schmitt to nominate Diane Auchter, 217 North Stratton Street, to the Recreation Board replacing Kirby Smith. This term will expire in September 1998. Motion carried.

Mr. Zellner reported the Utility Commission decided to submit the required paperwork to the FCC for certification so that we may regulate cable tv.

Moved Mrs. Rice, seconded Mr. Schmitt to approve all bills and payrolls. Motion carried unanimously.

Moved Mrs. Rice, seconded Ms. Giles to adopt the budget in the amount of \$2,255,924. Motion carried unanimously.

Moved Mrs. Rice, seconded Mr. Schmitt to adopt an Ordinance fixing the tax rates for the fiscal year 1994 as follows: real estate taxes 10.13 mills and occupation taxes 30 mills. Motion carried unanimously.

Moved Mrs. Rice, seconded Mr. Troxell to adopt an Ordinance fixing the Mayor's salary at \$4,000 per year. Motion carried unanimously.

Mr. Lawver was given authorization to prepare the bid for purchase of a new sweeper to replace the FMC. Bids will be prepared to seek alternatives to straight purchase.

Managers report:

A new life insurance policy will be provided to employees beginning January 1, 1994, keeping with terms of the police labor negotiations. All current policies will be cancelled and replaced with one policy that will cover police at \$50,000, managers at \$20,000, and all other employees at \$10,000. In addition, this policy will cover short term disability on all employees. The coverage is for employees only, not spouse or family.

Moved Mrs. Gustafson, seconded Mr. Troxell to authorize the cancellation of the present life insurance policies and enter into a new contract with Principal as proposed by the Leonard Ferrara Company. Motion carried unanimously.

The engineers have completed the survey of Kuhn Alley proposed. Mr. Oyler will prepare the necessary ordinance and public notices so the ordination process can proceed.

A workshop is scheduled for January 10 with the Planning Commission and URDC at 7:30 PM to review the work completed to date on the revisions to the comprehensive plan, subdivision ordinance and zoning ordinance.

The Personnel Committee and Rec Board will need to review the Rec Director applications.

Moved Mr. Troxell, seconded Mr. Schmitt to approve the Eichelberger-Stahle Charity Fund. Motion carried unanimously.

Mr. Lawver reported that they will be posting designated areas for street cleaning. Final brush and leaf pick up will begin the week of December 20. The Lincoln Square brick project is

scheduled to begin on March 7 and should take about 6 weeks. The highway crew will remove the 2 trees in late February to prepare for this project.

Mr. Little noted the letter of thanks from the Shoppes of Steinwehr Avenue for the free Christmas parking.

Dr. Powell reported that 3 of the 4 tenants at Brandon trailer park have been relocated.

Dr. Powell will be attending a meeting at the Ramada on December 15 sponsored by the National Park on Cultural Memorial Landscape. Attended a workshop for the Mayor in September at the Law & Planning Institute. They will be holding another workshop in Harrisburg on January 18 for anyone interested.

Chief Gantz thanked Mr. Ditzler for his dedication to the Borough and wished everyone Happy Holidays.

Mr. Perrson reported that they have 5 consultants interested in doing the study of the Wills House. A meeting is scheduled for next week to appoint the consultant. Displays have been donated to the Wills House for the Holidays.

Mr. Perrson reported that the application for the Shade Tree Grant in the amount of \$2,000 has been submitted for approval.

Moved Mr. Ditzler, seconded Mr. Schmitt to approve the reports submitted by the Treasurer, Chief of Police, Code Enforcement Officer and Parking Department. Motion carried.

Moved Mrs. Gustafson, seconded Mr. Zellner to approve HARB "consent agenda" including items C thru K. Motion carried unanimously.

Moved Mrs. Gustafson, seconded Mr. Schmitt to approve HARB recommendation of a proposed demolition and new construction of the Farnsworth House Complex at 401 Baltimore Street. Motion carried unanimously.

Moved Mr. Schmitt, seconded Mrs. Rice to approve the general plan under unfinished business item A and return to HARB for further review of the Frederick Douglass Project. Motion carried unanimously.

Moved Mr. Zellner, seconded Mr. Schmitt to approve item B under unfinished business, the placement of mechanical systems on the roof of the proposed "Fellowship Hall" to be constructed by the Gettysburg Presbyterian Church at the rear of 208 Baltimore Street. Motion carried unanimously.

Mrs. Gustafson suggested to Council that HARB prepare a booklet to be handed out to persons interested in renovations in the Historical District. This should be designed to give ideas of windows, doors, fences, etc. that would be appropriate for the Historical District.

Council recommended that HARB prepare such a booklet to better assist and inform the public with the operation of HARB.

Mr. Sterner read a Resolution recognizing Vice President J. William Ditzler for his 20 years of service to the community as a councilman from the Third Ward. The framed resolution along with an honorary gold police badge was presented to Mr. Ditzler.

Moved Mr. Schmitt, seconded Mr. Troxell to adopt a Resolution recognizing Mr. Ditzler for his outstanding service and 20 years of community service as a councilman. Motion carried.

Mr. Ditzler thanked council for the resolution noted some of the changes he has seen during his tenure as councilman.

With no further business Mr. Ditzler moved, seconded By Mr. Schmitt to adjourn the meeting at 9:10 PM.
