COUNCIL MEETING MINUTES JULY 11, 1994

Vice President Schmitt called the meeting to order at 7:30 PM with the following Councilors present: Mrs. Gustafson, Ms. Giles, Mr. Murphy, Mr. Troxell and Mr. Kreisher. Mrs. Simpson, Mr. Eline and Mr. Zellner were out of town. Also in attendance were Mayor Linn, Mr. Sterner, Donald Oyler, Solicitor, Mr. Lawver, Dr. Powell, Brad Pflugh, Mrs. Showvaker, Bill Walker representing the College, Lucy Basalla of the Gettysburg Times and Sharon Hare of the Hanover Evening Sun.

Moved Mr. Murphy, seconded Ms. Giles to approve the agenda as presented. Motion carried.

Moved Mr. Murphy, seconded Mr. Troxell to approve the discouncil meeting and public hearing minutes of June 13th as presented. Motion carried.

Mr. Schmitt welcomed everyone to the Council meeting.

Citizens in attendance:

The above citizens were here to discuss their concerns for speeding, loud noises from cars and boom boxes. They feel the police are not properly enforcing the laws. Youth gather at Hardee's Restaurant (not just Gettysburg residents but from other towns as well) and travel the streets into the early morning hours. The citizens would like to see something done to eliminate the problem to make a better impression on the tourists.

Jean McCrorie, 248 York Street, along with her Contractor, Glenn Kuykendall would like HARB to accept her previous proposal for metal doors.

Jim Cole, 51 East Stevens Street, attended to follow up on his HARB application.

Mr. Moyer and David Sandstedt attended to observe the meeting.

Shannon Smith-Brigaman with United Cerebral Palsy attended to represent Frank Faulkner who lives at the Fahnestock House. He is permanently in a wheel chair due to an accident and feels that his building is not accessible for wheel chairs to get in the front door. They need to have more ramps and more curb cuts. He requested the Borough should check into these problems to be certain they are following the ADA regulations.

Thomas Henninger, 314 East Railroad Street, is concerned with the rail road crossing on Rail Road Street proposed by Dal-Tile Corp. He has been having problems with the tractor trailer trucks running for long periods of time throughout the night. Suggested that this noise should be limited to certain hours and not permitted throughout the night.

Mayor Linn reported that he would be attending a Transportation Committee Meeting at the Holiday Inn.

Mr. Kreisher-Public Works Committee will have their next meeting on July 26 at 3:30. They will be discussing the shade tree ordinance to be presented at the next Council meeting.

Mr. Troxell-Legislative Committee reported that he is concerned that even longer truck will be permitted by PennDOT. He will keep Council informed of this.

Moved Mrs. Gustafson, seconded Mr. Troxell to approve HARB "consent agenda" for new signs C,D,E,B & H as presented. Motion carried unanimously.

Moved Mrs. Gustafson, seconded Mr. Troxell to approve HARB "consent agenda" for alterations F, G & I as presented. Motion carried unanimously.

"consent agenda" for new fences A & J as presented. Motion carried unanimously.

Ms. Giles-Public Safety Committee reported that the committee had a lot to discuss in June. Council should review the report prepared by Chief Gantz.

Moved Ms. Giles, seconded Mrs. Gustafson the Open Container Ordinance be advertised for adoption at the August Council meeting. Motion carried unanimously.

Moved Mr. Murphy, seconded Mr. Troxell to approve all bills and payrolls for the month. Motion carried unanimously.

Moved Mr. Murphy, seconded Mr. Kreisher to approve the reallocation of \$10,000 in 1993 "CDBG" Fiscal Year 1993 to a clearance activity to be used for the trailer removal at the Brandon Trailer Court, 230-232 South Washington Street. Motion carried unanimously.

Moved Mr. Murphy, seconded Ms. Giles to award the contract for Brandon Trailer Court removal to C. E. Williams in the amount of \$9,400. Motion carried unanimously.

Managers report:

Marty Miller is still showing 34 East Middle Street and several prospects appear to be very interested.

Moved Mr. Troxell, seconded Mrs. Gustafson to reappoint Mr. Murphy as Borough representative to the National Park Service Motion carried unanimously.

Moved Ms. Giles, seconded Mr. Kreisher to recommend Walter Powell be nominated to serve to the National Park Service Advisory Commission. Motion carried Unanimously.

Moved Mr. Murphy, seconded Mr. Troxell to adopt a Resolution establishing a \$5.00 fee to be paid to the Borough Tax Collector for issuing real estate tax payment certifications within the Borough. Motion carried unanimously.

Moved Mr. Murphy, seconded Ms. Giles to authorize the application for an intermunicipal grant in aid to the PA Department of Community Affairs in the amount of \$3,000 for purpose of improving police communications capabilities. Motion carried unanimously.

Moved Mr. Murphy, seconded Mrs. Gustafson to authorize the application for a Council of Government Grant in the amount of \$9,250 for the purpose of commercial vehicle enforcement. Motion carried unanimously.

Mrs. Showvaker reported that the Rec Board has requested a feasibility study for a swimming pool. The rec park is used very heavily, so the location of a pool may be desirable at another location. Currently working with other Townships to get their input. The Board is considering a restructuring so that other townships can have representation.

Mr. Lawver reported that the square project is just about The crew will be hauling brush and cleaning the tiber. Street sweeper will be in service this week.

With no further business Mr. Murphy moved, seconded by Mr. Troxell to adjourn the meeting at 9:40 P.M.
