Moved Mrs. Gustafson, seconded Mr. Zellner to approve the agenda as presented. Motion carried.

Moved Mr. Eline, seconded Mr. Zellner to approve the minutes of the June 12 meeting as presented. Motion carried.

Citizens in attendance: Bill Walker, representing Gettysburg College, Polly Parone, representing the Retail Merchants Association, and Gary Shaffer, HARB Chairman attended to answer any questions Council may have on the HARB report.

Moved Mrs. Gustafson, seconded Mr. Frazee to approve the old business from HARB "consent agenda". Ms. Giles abstained from the vote. Motion carried unanimously.

Moved Mr. Eline, seconded Mr. Zellner to approve HARB "consent agenda" for the June 28 meeting. Motion carried unanimously.

Ms. Giles reported that the July Safety Committee meeting has been cancelled.

Moved Mr. Schmitt, seconded Mr. Frazee to approve all bills and payrolls for the month. Motion carried unanimously.

Mr. Kreisher reported that the Public Works Committee has been notified that Sammons Communications Inc. has been purchased by Suburban Cable headquartered in Pottstown. Hank Lockard, district manager, will be invited to attend the next Public Works Committee to inform the committee of the change. See report for further information.

Mr. Eline had nothing to report for Community Development.

Mr. Zellner reported that the Human Relations Committee will meet this week to discuss a wage increase for Highway employee Jeff Gastley.

Sterner has arranged a meeting with the County Commissioners to negotiate a lease for 34 East Middle Street. The Borough will need to make renovations amounting to about \$20,000. Bond Counsel Frank Leber is preparing an RFP to send to several banks requesting quotations on borrowing up to \$250,000. A special meeting will be held on August 30 at 7:30 pm in Council Chambers to finalize the borrowing.

Mr. Oyler reported little progress on the Keystone lawsuit. Kim Patrono has lost his appeal to the County Commissioners, his property will remain taxed in the Borough. The Brandon condemnation issue has been given to a board of arbitration to determine the final price.

Mr. Zellner inquired about the remaining \$7,000 CSBG funds which were approved for rec salaries. DCA, as a result of the recent audit report, now wants the Borough to return the unused funds. Dr. Powell has requested DCA to reconsider the request.
