COUNCIL MEETING APRIL 9, 2001

Vice President Giles called the meeting to order at 7:30 PM with the following Councilors present: Mr. Andrews, Mr. Streeter, Mr. Monahan, Ms. Smith, Mr. Woodward and Mayor Troxell. Mr. Eline, Mr. Murphy and Mr. Fleet were absent. Staff present included: Manager Sterner, Secretary Stull, Solicitor Eastman, Chief Gantz, Code Enforcement Officer Weikert, Historic Preservation Officer Powell, Highway Superintendent Lawver, Main Street Director Trostle and Interim Rec Director Sanders.

Representing the press were Beth Kanagy of the Times, Stacy Ward of the Evening Sun and Tim Lambert of WGET.

Moved Mr. Woodward, seconded Mr. Monahan to approve the agenda as presented. Motion carried unanimously.

Moved Mr. Woodward, seconded Mr. Monahan to approve the Council meeting minutes of March 12 as presented. Motion carried unanimously.

Citizens in attendance:

Paul Witt, Liaison for the Gettysburg Convention and Visitors Bureau.

Gary Shaffer, 141 East Middle Street, Architect for The Pub & Restaurant. He responded to a letter from Walton Davis concerning the drawings for the new restaurant. Mr. Shaffer noted that buildings in town are not all Civil War buildings, such as the Adams County National Bank. He urged Council top approve the Pub plans as recommended by HARB.

Mark Aletto, Sunoco Gas Station, attended to hear HARB report.

Tom McGlaughlin, Landlord, reported that he was notified by CEO Weikert to evict his tenants on West Water Street. He wanted to appeal the notice. Mr. McGlaughlin sent letters to the students, college and parents and has no problem with evicting them but they will graduate in June. After he goes through the necessary procedure and expense of eviction the students will have already moved out.

CEO Weikert noted the RRU Ordinance states that tenants be evicted after 3 disruptive conduct notices. There is no provision in the ordinance that allows for an appeal. Solicitor Eastman noted the appeal would come later as a result of the district justice decision.

Michele Blevins, 31 West Water Street, is a neighbor to Mr. McGlaughlin's tenants. She reported that these college students misbehave badly and she has young children that should not have to be exposed to this. A landlord should not rent to irresponsible people and in all cases should keep very close tabs on them.

Raye Passmore and Richard Noble, Carlisle Street, owns the property that Michelle lives in and supports her concerns. Agrees with Mr. McGlaughlin that it is late in the year to evict these college students but he should have done something months ago.

Lisa Grim, The Pub & Restaurant, attended to seek Council's approval of the Pub plans. She would like to keep it the way locals and patrons have remembered the building for the past 40 years.

Jon Muller, 65 Steinwehr Avenue and Aaron Smith, 154 E. Middle Street were just visiting .

Ronald Karpin, a tourist from New Jersey, attended to observe Council.

Mayor Troxell reported that the From The Ground ^{Up} program will be holding a "Tunes For Trash" block party in June on Carlisle Street. Funds raised will purchase additional liter cans.

Mayor Troxell reported the South Central Assembly for Effective Governance will hold their annual conference on April 19 at Dickinson College.

Mr. Andrews noted the letter from the Commissioners in regards to the pillow tax and advised Council to let the Commissioners and the Visitors Bureau hash out the problems.

Mr. Andrews reported the Chamber of Commerce Governmental Cooperation Committee has arranged for county municipalities to meet on Monday, April 30 at Herr Tavern to discuss transportation issues with ACTPO.

Mr. Andrews reported that he and Mr. Monahan met with Senator Punt to discuss the pillow tax issue.

Mr. Streeter reported a letter was received from the Department of Transportation with comments on the draft CRIS report. Review copy in Council packet.

Mr. Streeter reported the Community Development Committee reviewed the housing report and has asked Solicitor Eastman to review the proposed changes to the zoning ordinance.

Moved Mr. Woodward, seconded Mr. Monahan to approve the ordinance laying out and opening Third Street from East Middle Street to Legion Alley. Motion carried unanimously.

Moved Mr. Woodward, seconded Mr. Monahan to approve the Quitclaim Deed to Dennis and Roberta Sullivan for a 2,360 square feet parcel adjacent to Third Street and authorize the President and Secretary to execute the deed. Motion carried unanimously.

Moved Mr. Andrews, seconded Mr. Monahan to approve all bills and payrolls for the month. Motion carried unanimously.

Manager Sterner reported the Finance Committee canceled their April meeting but will hold a joint meeting with the Legislative Committee on April 23.

Manager Sterner reported the Human Relations Committee will meet on Thursday, April 12 to discuss the death penalty moratorium.

Moved Mr. Andrews, seconded Mr. Monahan to approve HARB minutes of March 21, consent agenda items A,B,C,D,E & F as presented. Motion carried unanimously.

Council discussed at length item G, alterations and new signs for Sunoco at 225 York Streets.

Mr. Monahan suggested referring this back to HARB. He explained to Mr. Aletto that some canopies have come into sticky situations and they are just trying to eliminate any problems. Sunoco should make an exception here and blend the design to match our Historical District.

Mr. Aletto responded that they have over 3000 gas stations and when corporate makes changes they do all of them the same. He asked if solid color would be more acceptable in Gettysburg.

Mr. Streeter noted a change in a specific community should not be a problem for Sonoco.

Moved Mr. Monahan, seconded Mr. Woodward to send Item G back to HARB for further review. Motion carried unanimously.

Moved Mr. Monahan, seconded Mr. Woodward to approve HARB minutes of March 28, consent agenda Items A,C,D,E, and G. Motion carried unanimously.

Moved Mr. Andrews to approve Item F, The Pub. There being no second, his motion died.

Council then proceeded to discuss Item F, The Pub & Restaurant. Several noted the ideas noted in Walton Davis letter, that being to create a Civil War appearance on the new Pub, might be valid.

Dr. Powell reported that we don't know what the Pub looked like in 1863, it would be a guess. The earliest pictures are from 1888. Some suggest that a contemporary style, fitting in with the neighborhood, would be a preferred course. It would be practical for Ms. Grim to go with what the Pub looked like before the fire with all the codes updated. He asked Council not to accept Mr. Davis's opinion that HARB is harsh. If Council should refer this back to HARB, he doubted if they would make any changes to their original decision.

Ms. Smith agreed that delaying this process is not beneficial. This is a business community, people live and work here and that should also be considered.

Ms. Giles asked if the Deaner Property will need to follow the same course as The Pub. Dr. Powell indicated that the Deaner's have not yet come up with a plan.

Mr. Monahan asked Lisa Grim what brought her to the decision of stucco and not using brick. Ms. Grim responded that stucco has been there for many years and goes well with her color scheme. She prefers brick but feels the stucco will look the nicest. She and Mr. Shaffer thought it best to stay with what people remember of the building. Ms. Grim especially noted that the appearance of the building is part of her marketing.

Moved Mr. Woodward, seconded Ms. Giles to refer Item F, The Pub, back to HARB for further review. YEA: Mr. Woodward and Ms. Giles. NAY: Ms. Smith, Mr. Andrews, Mr. Streeter and Mr. Monahan. The motion failed.

Moved Mr. Monahan, seconded Mr. Woodward to approve HARB, item F, The Pub as presented. Motion carried unanimously.

Mr. Monahan reported that the College Relations Committee will meet in May.

Ms. Smith, Zoning Board Liaison, reported on the recent hearing.

Solicitor Eastman asked that Council approve he and Attorney Catherine Gault to represent the Borough in the matter of the High Street School zoning appeal. The Zoning Hearing Board's decision was appealed to County Court.

Moved Mr. Monahan, seconded Mr. Streeter approve Solicitor Eastman and Attorney Catherine Gault to represent the Borough in the zoning appeal. Motion carried unanimously.

Manager's report:

Sgt. Dennis Wright has announced his retirement effective Friday, April 13. Sterner noted that he has faithfully served the community for 28 years.

The Pennsylvania League of Cities and Municipalities will hold its annual conference in June. Council should appoint a voting delegate.

Moved Ms. Giles, seconded Mr. Streeter to appoint Bill Monahan as the voting delegate to the PLCM conference. Motion carried unanimously.

Moved Mr. Woodward, seconded Mr. Monahan to accept the tax exoneration report for tax years 1989, 1995, 1996, 1997, 1998, 1999 and 2000. Motion carried unanimously.

Mr. Monahan asked Chief Gantz if the police are taking time to look at the problem with college students and the reporting requirements in the RRU.

Chief Gantz noted that there isn't a problem with the police or CEO departments. Communication is good, notices are filed with the CEO. The problem is that Mr. McGlaughlin doesn't understand the procedures.

Solicitor Eastman suggested to Council they consider changing the RRU requirement to evict after the 2nd incident instead of the 3rd.

Mr. Trostle reported that Main Street has submitted an application under the Save America's Treasures Grant Program for Wills House funding.

Mr. Trostle finished his report by reporting the PA Downtown Center annual conference will be held in Gettysburg this year. All of Council is invited to attend.

With no further business, moved Mr. Andrews, seconded Mr. Woodward to adjourn the meeting at 9:20 PM.
