Mr. Rebert reported a bill listed for \$50.00 had been removed from the list. Moved Mr. Rebert seconded Mr. Shealer all approved bills and payrolls be paid. Motion carried.

Moved Mr. Rebert seconded Mr. Little that Council rescond the resolution passed October 8, 1973. Motion carried.

Finance Committee and Ordinance Committee directed to study the resolution and resubmit at a later date.

On Mr. Rebert's recommendation Council directed a letter be sent to the publisher of the Shopper's Guide objecting to present distribution methods employed by the distributor. A copy to be sent to L. E. Smith News Agency.

Mr. Delzingaro reported the Utility Committee is studying complaints received from the residents of the 100 block of York Street re the darkness of the alley north of their properties.

Mr. Miller reported the storm sewer project that crosses the Garlach property is nearing completion.

Moved Mr. Ditzler seconded Mr. Delzingaro the ordinance allowing not more than 5" encroachment on Borough right-of-way be adopted. Motion carried.

Moved Mr. Ditzler seconded Mr. Rebert that Council adopt the ordinance opening and ordaining two alleys east of Long Lane. Motion carried.

Moved Mr. Shealer seconded Mr. Rebert the ordinance amending Article II, Section 35 of Ordinance #137, be adopted. Motion carried.

Mr. Ditzler, Mr. Kuhn and Mr. Groft directed to meet with Mr. Oyler to study feasibility of amending the underground storage tank ordinance to include above ground installation of tanks for liquid petroleum.

Mr. Ditzler reported he had received several complaints: rats in the vicinity of the Pizza House; garbage strewn on the Recreation Park; the stop sign at South Washington Street and Breckenridge Street, facing north, partially obscured by a directional sign.

Mr. Shealer reported the Safety and Highway Committees had met and feel excessive speed is causing the problems at the Hanover Street-Fourth Street intersection. Mayor Lightner reported he had contacted the State Police re use of radar. He was advised the State Police can make arrests within the Borough after Radar Warning Signs have been erected.

Moved Mr. Shealer seconded Tr. Little that radar warning signs be exected on all State roads in the Borough. Motion carried.

Moved Mr. Shealer seconded Mr. Ditzler that an ordinance be drawn designating Fourth Street as a one way street with parking permitted on both sides of the street. Between York Street and Hanover Street direction of traffic - north; from Hanover Street to East Middle Street direction of traffic - south. Motion carried.

Moved Mr. Heflin seconded Mr. Rebert the Borough adopt the resolution approving the Agreement prepared by Anderson Page, Esq., bond counsel for the Gettysburg Municipal Authority to be entered into by the Gettysburg Municipal Authority and the surrounding townships. Motion carried.

Mr. Heflin announced a public hearing on the regional sewer system will be held

March 18, 1976 at 8 P.M. in the Court House.

Moved Mr. Heflin seconded Mr. Niebler that Council adopt a resolution approving the purchase of new equipment by the Gettysburg Fire Company. Motion carried.

Moved Mr. Niebler seconded Mr. Rebert that Mrs. Carol Bream, 910 Fairview Avenue, be appointed to the Recreation Board to fill the unexpired term of Robert White who has resigned. The term expires September 1976. Motion carried.

Moved Mr. Little seconded Mr. Rebert that Highway-aid money be used to rebuild Fourth Street from York Street south to East Middle Street and resurface two blocks of Highland Avenue during 1976. Fourth Street residents needing new curbs and sidewalks to be notified. The Utility Companies will be notified to enable them to complete any work needed in the area. Motion carried.

Mayor Lightner announced the resignation of Patrolman Larry Fetter, effective March 9, 1976.

Safety Committee recommended that another Civil Service test be given to obtain a list of candidates for any vacancies that may occur in the police department.

Moved Mr. Little seconded Mr. Ditzler that certificates of appropriateness be prepared as recommended by the H.A.R.B. for the following applications: Elks Lodge, House of Bender, Rea and Derick and Jay McDannell. Motion carried.

Mr. Kuhn reported two men will be attending a Medical Entomology Training Course on March 26th in Harrisburg presented by the State Health Department.

Moved Mr. Miller seconded Mr. Niebler that elimination of sump pump water on Chambersburg Street be given first priority. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin that Council ratify President Weikert's signing of the agreement between the Borough and the School District and the application for funds from the State for improvements at the Recreation Park and recreational facilities at the High School. Motion carried.

Moved and seconded the reports of the treasurer, mayor, police chief and H.A.R.B. be accepted. Motion carried.

Following Mr. Rebert's recommendation the Highway and Property Committees directed to get information and prices of snow loaders and submit for study.

Moved and seconded meeting adjourn. Motion carried.
