Moved Mr. Nielber seconded Mr. Ditzler that Joel Hill be appointed to serve a five year term on the Board of Appeals for Buildings. Motion carried.

Mr. Heflin reported the new police car is now in service. The Ford will be used by Mr. Kuhn, Mr. Groft or in an emergency as a back-up vehicle for the police department. Mr. Kuhn to be in charge of the car.

Moved Mr. Rebert seconded Mr. Little that the bill of Adams County Motors Corporation for \$298.00 be tabled for futher study. Motion carried.

Moved Mr. Shealer seconded Tr. Ditzler that Mr. Kuhn be given the authority to investigate the possibility of obtaining State Funds to up-grade radio equipment. Motion carried.

Moved Mr. Shealer seconded Mr. Heflin that Thomas R. Carr be employed as a probationary patrolman, effective April 4, 1976. Motion carried by majority vote with Mr. Neibler dissenting.

Moved Mr. Shealer seconded Mr. Ditzler that John S. Slaybaugh be employed as a probationary patrolman, effective April 18, 1976. Motion carried by majority vote with Mr. Neibler dissenting.

Mr. Shealer reported a *DOCTOR SPACE* has been provided on East High Street for Dr. Woods and Dr. Beckman.

Moved Mr. Shealer seconded Mr. Miller that the stop sign presently on South Howard Avenue be placed on West High Street at its intersection with South Howard Avenue. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer that Council adopt the amendment to the underground storage tank ordinance permitting installation of above ground tanks for liquid petroleum. Motion cearried by majority vote with Mr. Delzingaro dissenting.

Moved Mr. Ditzler seconded Mr. Rebert the ordinance setting the permit fee for L. P. tanks be adopted. Motion carried.

Moved Mr. Ditter seconded Mr. Little the ordinance making Fourth Street one way,

direction of travel-north from Hanover Street to York Street and south from Hanover Street to East Middle Street, be adopted. Motion carried by majority vote with Mr. Rebert dissenting.

Moved Mr. Ditzler seconded Mr. Niebler the ordinance permitting parking on both sides of Fourth Street from York Street south to East Middle Street be adopted. Motion carried.

Mr. Ditzler recommended Chief Cluck, through news articles and radion announcements issueswarnin's to bicycle riders that they must obey the Motor Vehicle Code.

Mr. Miller reported the storm sewer projects west of the High School and Long Lane have been completed.

Moved Mr. Delzingaro seconded Mr. Heflin that the Met-Ed resolution to move the light on Fourth Street be adopted. Motion carried.

Moved Mr. Delsingaro seconded Mr. Niebler that a light be placed in the alley north of the second block of York Street. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin that a light be erected at the Long Lane-Sunset Avenue intersection. Motion carried.

Moved Mr. Rebert seconded Mr. Ditzler all payrolls and approved bills, except the one for \$298.00 of Adams County Motors Corp., be paid. Motion carried.

Property adn Safety Committees and Mr. Kuhn to meet with Adams County Motors Corporation re the \$298.00 invoice.

Moved Mr. Rebert seconded Mr. Ditzler that Council approve the purchase of a 90 day certificate of deposit in the amount of \$39,157.45, highway-aid funds for 1976. Motion carried.

Property Committee to set date for Council to meet at the Highway Garage to study highway department needs.

Mr. Kuhn reported the following:

- 1. The Chamber of Commerce has obtained sufficient sponsors to have the Borough portrayed in the July issue of THE PENNSYLVANIAN.
- 2. The Telephone Company will install a phone booth in the northeast corner of the parking lot at the Gettysburg Shopping Center.
 - 3. Several persons have expressed an interest in buying the metal benches that w were used on Lincoln Square. Council decided that since the benches had been placed by the Lions Club, Council has no authority to sell them.

Moved Mr. Delzingaro seconded Mr. Rebert that certificates of appropriateness be prepared for the following as recommended by H.A. R.B: Styles by Stephanie; Department of Environmental Resources; Lincoln Diner; Lincoln Museum and Williard Weikert. Motion carried.

Moved Mr. Ditzler seconded Mr. Rebert the reports of the treasurer, mayor, police chief and H.A.R.B. be accepted. Motion carried.

The councilmen will survey curbs and sidewalks in their respective wards and submit a list of the Highway Committee who will study and determine the ones to be replaced or repaired this year.

Moved and seconded meeting adjourn. Motion carried.

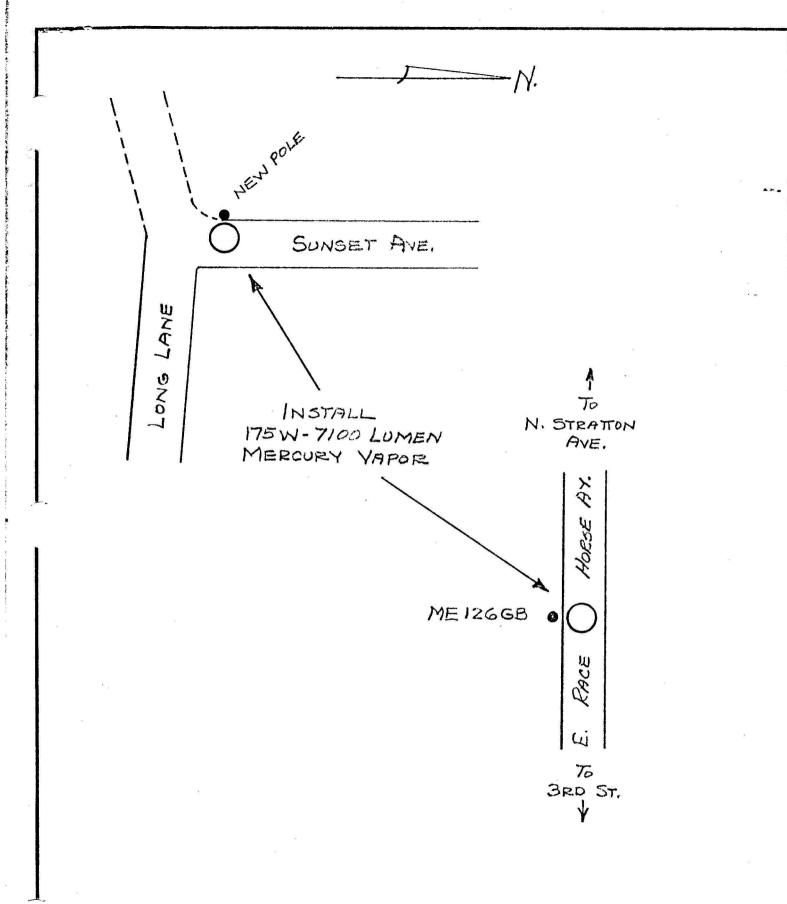
