The July meeting of Borough Council was called to order by President Weikert with the following Councilmen present: Messrs. Little, Niebler, Heflin, Shealer, Ditzler, Miller, Delzingaro and Rebert.

The minutes of the June meeting were approved as read.

C harles Huber appeared on behalf of Don Bream to have a meter bag placed on the meter beside the Bream home to provide a space for stopping to pick up and return Mr. Bream to his home. Highway and Safety Committee to study.

Oscar Spicer on behalf of the Gettysburg Fire Department presented a resolution requesting Council to instruct the Recreation Board that no activities be scheduled at Rec Park during the week of the Firemen's Carnival. Since the Little League field is enclosed by a fence and not utilized during the Carnival their schedule will not be affected.

Moved Mr. Rebert seconded Mr. Niebler that the resolution re Rec Park be adopted. Motion carried.

William Stock appeared before Council to express his disapproval of the architectural plans of the proposed Court House.

Attorney Pyle reported a small plot of ground, to provide a turning radius at the intersection of Legion Alley and Court Alley, hasbeen deeded to the Borough by the County Commissioners.

Commissioners Biesecker and Klunk, Mr. Pyle and Mr. Fredericks, a representative of their architectural firm were present to answer any questions that might be asked re the proposed Court House plans.

Moved Mr. Delzingaro seconded Mr. Shealer that Borough Council instruct the H.A.R.B. to take another look at the Court House question and consider the following options:

- 1. Maintain current recommendation that Council not issue a certificate of appropriateness
- 2. Stipulate additional reasons recommending why Council should not issue a certificate of appropriateness
- 3. Recommend that Council issue a certificate of appropriateness per County Commissioners request
  Motion carried, unanimous vote.

Mayor Lightner announced he had been requested to issue driveway permits at the Junior High School. Mr. Brubaker of the H. Edward Black Associates explained their reasoning behind the request, chiefly the safety of students waiting to cross the roadway. Moved Mr. Rebert seconded Mr. Ditzler that the permit be issued providing the radii and drive openings conform. Motion carried.

Mr. Brubaker also presented architects drawing of the layout of the tennis courts and basketball court to be built east of the Senior High School Building. Moved Mr. Niebler seconded Mr. Delzingaro that Council approve the plan as shown. Motion carried.

The Mayor announced the police are using foot patrol to quell the disturbances on Chambersburg Street caused chiefly by loitering.

Pres. Weikert reported William Troxell had contacted him regarding house numbers issued for the three stores to be opened on the East Middle Street side of the Stran Theater building. Moved Mr. Little seconded Mr. Niebler that the numbers issued are in accordance with the Ordinance and shall remain as issued by Mr. Kuhn. Motion carried.

Mr. Ed Weintraub on behalf of H.G.-A.C., Inc. extended an invitation to the Mayor and Councilmen to attend ceremonies at noon July 15th when Mr. Bixler will be commended as the first property owner to complete the restoration of his property. Mr. Weintraub also reported an indicator will be placed on Lincoln Square to reveal the progress of the restoration project.

Moved Mr. Delzingaro seconded Mr. Ditzler that Council approve the amendment changing the term of the agreement from 10 years to 20 years between the School District and the Borough. Motion carried.

Moved Mr. Miller seconded Mr. Rebert that J. R. Hershey be engaged to prepare a master plan for storm sewers to be installed by the Borough. Motion carried.

Moved Mr. Rebert seconded Mr. Little that Nelson J. Groft be appointed to serve as assistant treasurer in the absence of Mr. Kuhn. Motion carried.

Moved Mr. Rebert seconded Mr. Little that Mr. Groft purchase a 90 day certificate of deposit with the \$20,009.00 revenue sharing funds. Motion carried.

Moved Mr. Rebert seconded Mr. Ditzler all approved bills and payrolls be paid. Motion carried.

Mr. Niebler reported the DER had checked into the noise at the Dolly Madison Plant and have found their equipment to be functioning properly. It was determined some noise is inevitable. Mr. Niebler reported also that he had attended a Civil Defense meeting in June.

Moved Mr. Shealer that Council issue a statement of recognition commending all groups and individuals who participated or were respectable in any way for the success of the Bicentennial events. Motion seconded by Mr. Ditzler. Motion carried.

Moved Mr. Shealer seconded Mr. Rebert a resolution be adopted to apply to the State for reimbursement of expenses incurred by mandatory police training. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer the ordinance banning parking within 50 ft north of the entrance to the Evergreen Cemetery be adopted. Motion carried.

Moved Mr. Rebert seconded Mr. Heflin that Council adopt the resolution to apply to the State for 87 reimbursement of the planning expenses for the regional sewer facilities. Motion carried.

Moved Mr. Rebert seconded Mr. Delzingaro the \$1,000.00 allocated to the Library from Revenue Sharing Funds be paid. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer thereports of the Mayor, Police Chief and Treasurer be accepted. Motion carried.

Mr. Rebert expressed concern for bicycle riders who are violating traffic regulations.

Moved Mr. Shealer seconded Mr. Heflin that the Christian Book Store be given permission to use a temporary sign until the next Council meeting. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin that a certificate of appropriateness be issued for "Vick!'s Bridal Shop". Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer a certificate of appropriateness be issued for "Gilded Mirror". Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin the minutes of the H.A.R.B. be accepted. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer that the Borough's copy of the Proclamation, issued by the Mayor when the Freedom Train was in town, be framed. Motion carried.

Moved and seconded meeting adjourn. Motion carried.

## RESOLUTION

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania passed the Pennsylvania Sewage Facilities Act, Act No. 537 (P. L. 1535, as amended), and it was signed into law by the Governor of the Commonwealth on the 24th day of January, A.D. 1966; and

WHEREAS, under the provisions of Act 537, as amended, and the rules and regulations of the Department of Environmental Resources, promulgated for the administration of said act, each municipality of the Commonwealth is required to prepare and submit to the Department of Environmental Resources an officially adopted plan for sewage systems serving areas within its jurisdiction; and

WHEREAS, the Borough Council of Gettysburg Borough,

Adams County, Pennsylvania, has prepared a sewage facilities plan
in accordance with the provisions of the Pennsylvania Sewage

Facilities Act, as amended, and the rules and regulations of the

Department of Environmental Resources promulgated for the
administration of said act; and

WHEREAS, said plan recommends an adequate system for the collection, conveyance, treatment, and disposal of sewage from the Borough of Gettysburg.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania, that:

1. The Borough Council does hereby adopt, as the official sewage facilities plan of the Borough, the "Wastewater Management Facilities, 201 Facilities Plan, 1976" as prepared by Gannett Fleming Corddry and Carpenter, Inc. and transmitted to the Borugh Council; and

- It is the intent of the Borough Council to subsequently implement said plan to the best of its ability; and
- 3. It is also the intent of the Borough Council to review and update or amend said plan as and when deemed necessary by the Borough Council, or as may be necessary to comply with the rules and regulations of the Pennsylvania Department of Environmental Resources.
