

## Minutes of December 13, 1976

The December meeting of Council was called to order by President Weikert with the following Councilmen attending: Messrs. Little, Rudisill, Heflin, Shealer, Ditzler, Miller, Delzingaro and Rebert.

The minutes of the November meeting were approved as read.

Moved Mr. Shealer seconded Mr. Ditzler that Mr. Weintraub proceed with preparation of Federal forms to apply for grants totaling 1½ million dollars to be used within the Historic District. Motion carried.

Moved Mr. Heflin seconded Mr. Little the bid of Adams County Motors Corporation to furnish 1974 used pick-up truck 3/4 ton, be accepted. Price \$2,400.00. Motion carried.

Moved Mr. Heflin seconded Mr. Shealer that Council accept the bid of O.C. Rice, Inc. to furnish Massey Ferguson Tractor and front-end loader for \$11,242.84 with trade-in of Case tractor and loader. Motion carried.

Moved Mr. Heflin seconded Mr. Shealer that Council accept the bid of Stephenson Equipment, Inc. to furnish a Nelson R-20 Snowloader - cost \$34,550.00. Motion carried.

Mr. Ditzler announced the amendments to the Zoning Ordinance will be advertised and adopted at the January meeting.

Moved Mr. Rebert seconded Mr. Ditzler that all approved bills and payrolls be paid. Motion carried.

Moved Mr. Little seconded Mr. Shealer that Council adopt the \$570,049.00 budget for 1977. Motion carried by majority vote, Mr. Rebert dissenting.

Moved Mr. Rebert seconded Mr. Heflin that Council adopt a 15 mill real estate and 15 mill occupation tax rate for 1977. Motion carried.

Mr. Little reported \$692.00, Eichelberger-Stahle Fund, have been distributed among 31 families.

Moved Mr. Rudisill seconded Mr. Ditzler that Robert Monahan, Sr. be appointed to serve a five year term on the School Board Authority; Orville Orner to serve a five year term on the Borough Planning and Zoning Commission; Philip Jones to serve a three year term on the Zoning Hearing Board. Motion carried.

Mr. Heflin reported the Police are using the back-up car while the Chevrolet is being repaired.

Moved Mr. Miller that the motion he made at the November meeting be rescinded, rel to granting the rate increase to Keystone Communicable, Inc. Mr. Heflin seconded the motion. Motion carried.

A letter was read from the Internal Revenue Service requesting use of the Council Chambers for 3 visits to aid persons filing their income taxes. Moved Mr. Rebert seconded Mr. Little that the request be granted. Motion carried.

Moved Mr. Ditzler seconded Mr. Rebert that Mr. Groft be empowered to apply for Disaster Relief for damages incurred during October '76 flood. Motion carried.

Moved Mr. Rebert seconded Mr. Little that money be transferred from the 1976 Health Department budget to Recreation Department and Miscellaneous Department to

eliminate the deficits in those departments. Motion carried.

Moved Mr. Rebert seconded Mr. Ditzler that certificates of appropriateness be prepared as recommended by H.A.R.B. for Attorneys Campbell and Neuhasuer to renovate property at 50 West Middle Street as shown on drawings, without bay windows; J-C Cleaners, Railroad Street for a 2' x 8' wooden sign with trough lighting. Motion carried.

Moved Mr. Delzingaro seconded Mr. Ditzler that Council accept the forms, "Application for Certificate of Appropriateness", as prepared by the Department of Community Affairs and have 300 copies printed. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the reports of the Mayor, Treasurer, Police Chief, and H.A.R.B. be accepted. Motion carried.

Moved and seconded meeting adjourn. Motion carried.

## RESOLUTION

WHEREAS, Keystone Communicable, Inc. (formerly Gettysburg TV Cable, Inc.) has applied for authorization under Section VI of Ordinance 893-75 adopted January 13, 1975, to increase the rates authorized by that section; and

WHEREAS, a public hearing on such application, after notice duly give, was held by Gettysburg Borough Council on December 22, 1976, at 7:30 o'clock, P. M., in the Council Chamber of the Borough Building, 34 East Middle Street, Gettysburg, Pennsylvania.

NOW THEREFORE, after consideration of the testimony given at such hearing, upon motion duly made, seconded and carried, it is

RESOLVED, that Keystone Communicable, Inc. is hereby authorized to change the rates authorized by Section VI of Ordinance 893-75 adopted January 13, 1975, as follows:

"The Company's initial charge for installation of a single residential television connection shall not exceed Fifteen (\$15.00) Dollars and the monthly subscriber fee for the service provided shall not exceed Seven Dollars and Fifty Cents (\$7.50) per month, plus Two (\$2.00) Dollars for each additional television sets connected to the cable by the subscriber. The charge for each FM Stereo set connected to the cable by the subscriber shall not exceed Two (\$2.00) Dollars per month. The charge for transfers and reconnections ~~for the service provided~~ shall not exceed Fifteen (\$15.00) Dollars. ~~No change in the rates authorized in this section shall be made by the Company unless authorized by the Borough of Gettysburg after an appropriate public proceeding affording due process.~~"
