MINUTES OF MEETING HELD JUNE 13, 1977

President Weikert presided at the June meeting of Council with the following councilmen in attendance: Messrs. Ditzler, Delzingaro, Rebert, Shealer, Heflin, Rudisill and Little.

The minutes of the regularly scheduled May meeting and of the Special Meeting held May 31, 1977 were approved as read.

Mayor Lightner reported he and Chief Cluck had met with DMI Officials re noise and were informed a new device will be installed within 20 days in an effort to help control the noise. The Mayor recommended the Safety Committee study the Breckenridge Street-West Street intersection and consider placing stop signs at that location.

Moved Mr. Ditzler seconded Mr. Heflin that Council accept the proposed ordinance requiring fuel delivery trucks to block at least two drive wheels while dispensing or loading liquid fuels. The ordinance to be advertised and adopted at July meeting. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer that the ordinance listing lengths of yellow lines be amended to include the following:

Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer four meters be removed on Baltimore Street and one added on Carlisle Street as recommended by the Safety Committee. Motion carried.

The Sewer Committee directed to study conditions on West Lincoln Avenue to determine best location for placing storm sewer.

Moved Mr. Little seconded Mr. Heflin that \$60,000 General Funds be invested in a ninety day certificate of deposit. Motion carried.

Moved Mr. Little seconded Mr. Delzingaro that Council give \$2,500 Revenue Sharing Funds to Gettysburg Fire Company to help defray expense of repairing Fire Truck. Motion carried.

Moved Mr. Little seconded Mr. Heflin all approved bills and payrolls be paid. Motion carried.

Moved Mr. Little seconded Mr. Ditzler the motion requiring curbs and sidewalks on Victor Street be amended to require Edward Warren to place curbing only. Motion carried.

Moved Mr. Little seconded Mr. Delzingaro that Kermit Tressler be notified to place sidewalk on the Pine Street side of his property. Motion carried.

Moved Mr. Heflin the motion made at the April meeting of Council to advertise for bids for a 2,000 gallon fuel tank, pumps and gasoline be rescinded. Motion seconded Mr. Ditzler. Motion carried.

Mr. Heflin reported efforts are being made to reorganize the County Association of Boroughs. Council unanimously favors the reorganization. Borough Officials from throughout the County are invited to attend a meeting held June 20th at the Court House.

Moved Mr. Shealer seconded Mr. Rebert an ordinance be drawn to install 10 hour meters on the north side of East Middle Street between South Stratton Street and Liberty Street. Motion carried.

Moved Mr. Shealer seconded Mr. Heflin the Safety Committee study the feasibility of adopting an ordinance that would prohibit the transportation or carrying of loaded firearms within the Borough. This would not apply to persons who had obtained a permit. Motion carried.

Moved Mr. Rebert seconded Mr. Delzingaro that Mr. Groft pay the bill presented by the Plumbing Contractor (Gettysburg School Park Project) for \$1,309.50 as soon as a check in this amount is received from the School District. Motion carried.

Moved Mr. Heflin seconded Mr. Shealer Council accept Leon Young's bid of \$494.00 for 1974 Ford Police car. Motion carried.

Moved Mr. Miller seconded Mr. Shealer that Council accept the bid of Chemung Supply Corp. for \$13,272 for 2500 ft 18" pipe and 500 ft 15". Motion carried.

Moved Mr. Heflin seconded Mr. Rudisill that Council issue a certificate of appropriateness for sign "Mr. Ed's Peanut Sack" as recommended by H.A.R.B. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin the recommendation of H.A.R.B. be accepted and a certificate of appropriateness be issued for exterior renovations to Thick & Thin Pizza Shop. Motion carried.

Moved Mr. Rudisill seconded Mr. Shealer that a certificate of appropriateness be issued as recommended by H.A.R.B. for sign at Robbie Pizza. Motion carried.

Moved Mr. Heflin seconded Mr. Ditzler the recommendation of H.A.R.B. be accepted and a certificate of appropriateness be issued for sign at Executive Club. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin the recommendation of H.A.R.B. be accepted and issue a certificate of appropriateness for sign at Brass 'N' Glass Nook. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the reports of the Mayor, Chief of Police Treasurer and H.A.R.B. be accepted. Motion carried.

Moved and seconded meeting adjourn. Motion carried.
