

Minutes of Meeting Held Aug. 8, 1977

The August meeting of Council was called to order at 8 P.M. with President Weikert presiding. The following Councilmen attended: Messrs. Ditzler, Miller, Delzingaro, Shealer, Heflin and Rudisill.

The minutes of the July meeting were approved as amended.

Moved Mr. Shealer seconded Mr. Heflin that Council accept the recommendation of the Safety Committee and prohibit parking on the west side of Third Street between East Middle Street and Hanover Street. Motion carried.

Moved Mr. Shealer seconded Mr. Heflin that a stop sign be placed on the north side of Breckenridge Street and another on the west side of West Street where the two streets meet. Motion carried.

Mr. Heflin reported Sixth Street has been tarred and chipped and will be open to traffic in a few days.

Mr. Heflin reported he has been advised that since curbs have been placed on Victor Street there is a flooding problem, near the bridge on Fourth Street. Mr. Kuhn reported the resurfacing of the roadway should correct the situation, if not, a drop inlet will be placed on Fourth Street.

Moved Mr. Heflin seconded Mr. Ditzler that Mr. Kuhn contact School Officials re water covering the walkway by the tennis courts on Lefever Street. Council is interested in getting rid of the water at this time, however, when all work is completed a notice will be sent to place a concrete sidewalk. Motion carried.

It was reported cars are parking on the grass and walkway along Lefever Street by the basketball court. Following the discussion Council directed signs prohibiting parking be placed along the entire street.

Moved Mr. Heflin seconded Mr. Ditzler that sidewalk notices be sent to the Elks Club and Gettysburg Shopping Center. Elks Club to replace sidewalk on South Stratton Street side of their property and make needed repairs on the York Street side. The Shopping Center to replace metal plates covering rain gutters along West Middle Street and make any needed concrete repairs. Motion carried.

Mr. Delzingaro reported briefly on the Recreation Board meeting held last month.

Mr. Miller reported the East Middle Street storm sewer is progressing, should be finished by the end of the week.

Moved Mr. Ditzler seconded Mr. Delzingaro that Council adopt the ordinance requiring fuel delivery trucks to block two drive wheels. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer that the ordinance designating the second block of East Middle Street, between South Stratton and Liberty Streets, as a metered area be adopted. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the parking meter ordinance be amended to include installation of 10 hr meters on East Middle Street. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin that Council adopt the amendment prohibiting parking at additional yellow line locations. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer the ordinance ordaining Constitution Avenue from North Washington Street to West Broadway, be adopted. Motion carried.

Moved Mr. Ditzler seconded Mr. Shealer that all approved bills and payrolls be paid. Motion carried.

Mr. Kuhn directed to contact Met-Ed rel to having trees trimmed that are blocking street lights.

Moved Mr. Delingaro seconded Mr. Heflin that a certificate of appropriateness be issued for H.G.-A.C.Inc. sign proposal as recommended by H.A.R.B. Motion carried.

Moved Mr. Shealer seconded Mr. Heflin the recommendation of H.A.R.B. be accepted and a certificate of appropriateness be issued for renovations to Donald Weaver property. Motion carried.

Moved Mr. Delzingaro seconded Mr. Ditzler a certificate of appropriateness be issued as recommended by H.A.R.B. for a sign proposal of Thick and Thin Pizza. Motion carried.

Moved Mr. Rudisill seconded Mr. Heflin a certificate of appropriateness be issued as recommended by H.A.R.B. for a sign proposal of Adams County Council on Drug and Alcohol Abuse. Motion carried.

Moved Mr. Ditzler seconded Mr. Miller the Council accept the reports of the Mayor, Treasurer, Chief of Police and H.A.R.B. Motion carried.

Moved Mr. Ditzler seconded Mr. Delzingaro that Mr. Kuhn be authorized to:

1. Cash two certificates of deposit (30,000 and 20,000) and place in General Fund.
2. Pay H. J. Williams bill of \$13,509 as soon as a check in this amount is received from the School District.
3. Cash Recreation Department certificate of deposit in the amount of \$4,029.19 and deposit in Special Recreation Fund.
4. Transfer \$110.78 from General Fund to Special Recreation Fund. (Interest check erroneously placed in General Fund).

Motion carried.

Moved Mr. Heflin seconded Mr. Shealer that "No Parking" signs be placed on both sides of Sixth Street from first alley south of York Street to Hanover Street. Motion carried.

Mr. Kuhn reported 26 notices for sidewalk and curb repair or replacement have been mailed. (List below)

Moved and seconded meeting adjourn at 9:50 P.M. Motion carried.
