Moved Mr. Delzingaro seconded Mr. Ditzler the sign application of Apple Tree Boutique be approved and a certificate of appropriateness be issued as recommended by H.A.R.B. Motion carried.

Moved Mr. Delzingaro seconded Mr. Heflin the sign proposal of Anne Faber be approved and a certificate of appropriateness be issued as recommended by H.A.R.B. Motion carried.
