The minutes of the September meeting were approved as read.

Kate Mangan and Barbara Romero residents of the first block of Breckenridge Street complained of the lack of parking facilities and of speeders who ignore the one-way signs. They suggested signs be erected for the protection of the children. Safety Committee to study.

Mayor Lightner reported Mrs. Irene Woerner has been employed on a probationary basis as secretary for the Police Department.

Mr. Heflin, a member of the Advisory Group for the regional sewer, authorized to send a letter to Mr. Zinn conveying Council's approval of the designated service area.

Mr. Heflin reported the utility companies and any property owners, needing curb or sidewalk work along the streets scheduled for reconstruction in 1980, will be notified now to have work completed by May 15.

Moved Mr. Lawver seconded Mr. Heflin that Charles B. Bender, Sr. be appointed to fill the unexpired term of the late Julian Estep on the Gettysburg Area Industrial Development Authority. Mr. Benders term to expire July 1981. Motion carried.

Moved Mr. Lawver seconded Mr. Ditzler Council re-appoint Ray Culp to another five year term on the Gettysburg Area Recreation Board. Motion carried.

Moved Mr. Lawver seconded Mr. Heflin Council re-appoint Randall Inskip for a five year term on the Historic Architectural Review Board. Motion carried.

Mr. Rudisill reported the Property Committee has accepted the bid of Charles Kerrigan to paint the Police Department. Mr. Groft directed to have the work done.

Moved Mr. Delzingaro seconded Mr. Heflin all approved bills and payrolls be paid. Motion carried.

Clyde Williams, who has served for ten years on the Recreation Board, declined re-appointment. Recreation Board recommend a letter of commedation be sent Mr. Williams.

Mr. Reimer to contact St. Francis Officials re buses unloading on the south side of the street.

Mr. Reimer reported on CAA Board meeting held last month. To comply with State regulations the board must be comprised of 30 members. (One third from public sector, one third from poor sector and one third private sector). Borough Council's next representative will be recommended to the County Commissioners who will make the appointment

Moved Mr. Reimer seconded Mr. Ditzler the ordinances to ordain Slentz Alley, extension of Hazel Alley and the extensions of King Street, Lone Lane and Sunset Avenue be advertised for adoption next month.

Moved Mr. Miller seconded Mr. Ditzler the candlepower in the three lights on Baltimore Street (between Middle and High) be increased as requested by the Retail Merchants. The vote by show of hands revealed a 4 to 4 tie. President Shealer voted in favor of the motion. Motion passed 5 to 4.
