

The March meeting of Council was called to order at 7:30 PM by President Shealer. The following Councilmen attended: Messers. Ditzler, Heflin, Miller, Lawver, Swope, Madsen, Witt and Rinehart.

The minutes of the February meeting were approved as read.

Moved Mr. Miller seconded Mr. Swope Council approve the recommendation of Mayor Lightner and Chief Wells to promote Charles Fritz and Walter Gliem from Patrolman to Patrolman First Class. Fritz's promotion effective February 27 and Gliem's effective March 12, 1980. Motion carried.

Moved Mr. Lawver seconded Mr. Ditzler an amendment to the Animal Ordinance be prepared and advertised for adoption that would require dogs to be kept on a leash rather than running loose and the amount of the fine to be increased. Also the parking meter ordinance be revised to read "parking enforcement officer" instead of parking meter enforcement personnel. Motion carried.

Moved Mr. Ditzler seconded Mr. Swope all approved bills and payrolls be paid. Motion carried.

Moved Mr. Witt seconded Mr. Swope the Borough conduct a Spring Clean-up. Dates to be chosen and announced by the Borough Manager. Motion carried.

Moved Mr. Witt seconded Mr. Swope the Borough purchase a reconditioned chipper from Asplundh Tree Expert Company for \$2,400.00. Motion carried.

Moved Mr. Swope seconded Mr. Madsen James Shanefelter, 170 Carlisle Street, be appointed Second Ward Assessor. Motion carried.

President Shealer reported the date of 1786 will be used on the Official Borough Flag. Additional research confirmed that date.

Moved Mr. Heflin seconded Mr. Witt the Borough Manager and Code Enforcement Officer be allocated ten gallon of gasoline weekly from the Highway Department pump. Should a long trip be necessary they would fill their tanks. Motion carried.

Moved Mr. Lawver seconded Mr. Miller Council accept the bid of Don Warner Chevrolet-Buick Inc. for 1980 Chevrolet Impalla Police Car - cost \$7,275.36. Motion carried.

Moved Mr. Swope seconded Mr. Lawver Council reject the G. H. Harris recommendation for exonerations. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin the reports of the Mayor, Police Chief and Treasurer be accepted. Motion carried.

It was announced Barry Hallett is the Gettysburg Fire Department's representative to Council.

Moved Mr. Ditzler seconded Mr. Heflin Council accept the Fire Department's report. Motion carried.

Moved Mr. Heflin seconded Mr. Miller the proposal of "Mr. Ed" to move an approved sign from Carlisle Street to new store on Chambersburg Street be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Witt seconded Mr. Swope the recommendation of HARB for the sign proposal of Carroll Zents for the former Scharf & Bigham Building be rejected. Motion carried.

Moved Mr. Swope seconded Mr. Heflin the proposal of Mrs. Ruth Kuhn to place vinyl siding on her property be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Madsen seconded Mr. Ditzler the Chamber of Commerce proposal to repaint and letter an existing approved sign be accepted and a certificate of appropriateness issued. Motion carried.
