

MINUTES OF MEETING HELD MARCH 9, 1981

President Shealer called the meeting to order at 7:30 PM. Councilmen attending Messrs. Madsen, Witt, Ditzler, Heflin, Miller, Cluck and Delzingaro.

The minutes of the Second Public Hearing for Revenue Sharing Fund Use and of the February Council meeting were approved as read.

Jim Nett presented drawing of proposed pavilion the Gettysburg Fire Company plans to erect at the Recreation Park. Moved Mr. Delzingaro seconded Mr. Madsen Council tentatively approve the Fire Company plans pending recommendation of Recreation Board. Motion carried.

Attorney Campbell appeared on behalf of Jack Waybrant and recommended Council consider the repeal of the ordinance banning self service stations. Ordinance Committee directed to study.

Messrs. Horner and Arthur, representatives of Keystone Communicable reported the check for the 1980 franchise fee should be here by the April meeting of Council. After listening to various complaints re service interruptions they urged patrons to use the toll free number to report problems as they occur.

Attorney Ruth asked Council to extend the time (30days) and drop the penalty and interest for the unpaid 1980 Amusement Taxes for the Retreat. Moved Mr. Witt seconded Mr. Cluck the action of Council at the February meeting rel to the Retreat stand as approved at that time. Motion carried.

Moved Mr. Delzingaro seconded Mr. Madsen Council approve the application of the Gettysburg National Bank for a "Time & Temperature" sign as HARB recommended and a certificate of appropriateness be issued. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin Council accept HARB minutes. Motion carried.

Mayor Lightner reported the Borough is in need of a current list of persons eligible for appointment to the police force. Moved Mr. Miller seconded Mr. Cluck a civil service exam be scheduled. Motion carried. Safety Committee directed to contact Civil Service Commission.

The Mayor thanked the Highway Department for recent snow removal work-especially plowing the alleys.

Moved Mr. Ditzler seconded Mr. Madsen all approved payrolls and bills (\$13,670.58) except the Sound Electronics (\$400.00) bills for installation of scramblers be approved for payment. Motion carried.

Mr. Witt announced there is a possibility of establishing a municipal 26 vehicle parking lot utilizing area at the rear of the Chamber of Commerce property and a portion of the former Moose parking lot. Parking Lot Committee directed to pursue possibility.

Mr. Delzingaro directed Council's attention to several items listed in the Recreation Department annual report. Following Mr. Delzingaro's suggestion that the following situations be studied President Shealer directed the following committees check into the matters:

1. Health & Highway Committees to consider placing additional trash containers around town
2. Safety Committee to consider erection of "Children at Play" signs; motorists running the stop sign at Breckenridge & South Washington Streets; study the Franklin and West Middle Street intersection.

Moved Mr. Ditzler seconded Mr. Madsen Council appoint David Johnson to fill the vacancy created on the Recreation Board by the resignation of Ronald Heiges. The term to expire September 1985. Motion carried.

Mr. Heflin reported the highway workmen have cleaned and waxed all the highway equipment and police cars during the winter.

Moved Mr. Heflin seconded Mr. Ditzler the following bids be accepted. Motion carried.

Moved Mr. Madsen seconded Mr. Cluck the Borough adopt the interim tax system as instituted by County Commissioners. Motion carried by majority vote, Mr. Heflin dissenting.

Moved Mr. Ditzler seconded Mr. Madsen Council accept the reports of the Mayor, Chief of Police, Treasurer, Code Enforcement Officer and Fire Company. Motion carried.

Mr. Heflin suggested Pet Milk be advised the Borough is interested in retaining the existing agreement rel to the plot of ground on North Franklin Street.

Moved and seconded meeting adjourn at 9:35 P.M. Motion carried.
