

MINUTES OF MEETING - DECEMBER 12, 1983

President Shealer called the December meeting of Council to order at 7:30 PM with the following Council members in attendance: Messrs. Heflin, Miller, Cluck, Ditzler, Witt, Madsen, Mrs. Daniels and Mrs. Romero.

The minutes of the November Council meeting and of the Public Hearing held November 14, were approved as read.

Visitors included members of "The Chemical People Task Force"; three new councilmen elect, namely, Messrs. Hartzell, Schmitt, Delzingaro; Fred and Charles Rodgers, nephew of Mayor Weikert.

Moved Mr. Ditzler seconded Mr. Madsen Council approve the Resolution, as read by President Shealer, expressing Council's appreciation to Mayor Weikert for his untiring efforts on behalf of the Borough. Motion carried.

President Shealer thanked Council members Daniel P. Miller and Barbara A. Romero for their service to the Borough as Council members.

Moved Mr. Cluck seconded Mr. Madsen Council adopt the following resolution:

"Resolved, the Council of the Borough of Gettysburg recognize the untiring efforts and devotion to the people of Gettysburg by the retiring members of Council, namely, Daniel P. Miller and Barbara A. Romero. A copy of this resolution to be sent each one and made a part of the Minutes of this meeting." Motion carried.

Moved Mr. Miller seconded Mr. Madsen the traffic flow in Race Horse Alley remain unchanged. Motion carried by majority vote - Mrs. Daneils dissenting.

Moved Mr. Heflin seconded Mr. Ditzler Council adopt the 1984 Highway-aid Budget in the amount of \$97,776.86. Money to be used in rebuilding North Franklin Street and repaving of West Railroad Street. Motion carried.

Mr. Heflin thanked Council for the cooperation he received as a councilman and said he was looking forward to working with the new council.

Moved Mrs. Daniels seconded Mr. Madsen Council appoint George E. Hikes to a five year term on the Gettysburg School Board Authority; also Harry L. Hendricks to fill the unexpired term of Anthony R. Delzingaro. Mr. Hendricks term to expire December 1986. Motion carried.

Moved Mrs. Daniels seconded Mr. Heflin Council appoint Carl Payden to a five year term on the Borough Planning and Zoning Commission. Motion carried.

Moved Mrs. Daniels seconded Mr. Madsen Council appoint George S. Forney to a three year term on Zoning Hearing Board. Motion carried.

Moved Mrs. Daniels seconded Mr. Cluck Council appoint Melvin D. Crouse to a five year term on Gettysburg Municipal Authority. Motion carried.

Moved Mrs. Daniels seconded Mr. Cluck the ordinance regulating parking on West High Street be advertised for January adoption. Motion carried.

Mrs. Daniels conveyed the thanks of SPCA for the Borough's contribution.

Moved Mr. Ditzler seconded Mr. Witt all approved bills and payrolls be paid. Motion carried.

Moved Mr. Ditzler seconded Mr. Madsen Council adopt the 1984 Budget in the amount of \$989,731. Motion carried.

Moved Mr. Ditzler seconded Mr. Cluck the tax rate for 1984 remain same, 20 mills for real estate and occupation. Motion carried.

Moved Mr. Madsen seconded Mr. Cluck the list of 18 families as presented be recipients of the interest derived from Eichelberger-Stahle funds, total \$643.16. Motion carried.

President Shealer discharged the committee with thanks.

Moved Mr. Ditzler seconded Mr. Witt the Treasurer be authorized to bring all accounts to a zero balance on December 31, 1983. Motion carried.

Mr. Sterner read a letter from Mack Realty Co. rel to metering their parking lot.

Moved Mr. Heflin seconded Mr. Cluck Council approve the recommendation of G. H. Harris Associates to exonerate Jeffrey E. Marker for 1982 personal taxes. Motion carried.

A note of thanks from the Weikert family was read as well as a letter from Mayor thanking Council for the opportunity of serving the interim term.

Moved Mr. Ditzler seconded Mr. Madsen the reports of the Mayor, Chief of Police, Treasurer and Code Enforcement Officer be approved. Motion carried.

Moved Mr. Madsen seconded Mr. Cluck the sign proposal of Dr. John H. Dufendach be approved as HARB recommended and a certificate of appropriateness issued. Motion carried.

Moved Mr. Ditzler seconded Mr. Cluck the sign proposal of ABCO be approved and a certificate of appropriateness be issued as recommended by HARB. Motion carried.

Moved Mrs. Daniels seconded Mr. Madsen Council approve the certificate of appropriateness as recommended by HARB for the addition to the Dobbin House. Motion carried.

Moved Mr. Ditzler seconded Mr. Heflin Council approve HARB Minutes. Motion carried.

Moved Mr. Cluck seconded Mr. Madsen a resolution be approved limiting membership on Gettysburg Municipal Authority to five members. Motion carried.

Moved and seconded meeting adjourn at 8:50 PM. Motion carried.
