

MINUTES OF COUNCIL MEETING & PUBLIC HEARING HELD JOINTLY JAN. 14, 1985

The January meeting of Council and the public hearing, rel to renewal of TV Cable franchise, was called to order at 7:30 PM by ~~Mr.~~ President Shealer. Council members present: Messrs. Ditzler, Witt, Madsen, Mrs. Daniels, Messrs. Delzingaro, Schmitt, Hartzell and Linn.

The Minutes of the regular December meeting and of the Special Meeting held December 27th were approved.

Mark Hess, TV Cable representative, presented a copy of the cable franchise for renewal. Mr. Delzingaro, on behalf of the Ordinance Committee, expressed concern rel to the length of time covered by the franchise. (10 years). The Committee proposed Council should receive an annual report and review of operations as a precautionary measure against any undesirable situations that could occur during a ten year period. Mr. Hess felt this would not create a problem. Mr. Hess, Mr. Sterner and Attorney Oyler to confer re the addition of this request to the Agreement.

Moved Mr. Delzingaro seconded Mr. Schmitt Council renew the Cable TV Franchise, effective January 14, 1985 for ten years, on condition the above discussed details are included in the Agreement. Motion carried.

Moved Mr. Schmitt seconded Mr. Witt Keystone Communicable be granted the \$2.00 rate increase (\$10.50), effective February 1, 1985. Motion carried.

Moved Mr. Linn seconded Mr. Hartzell, Council award the bid to Elliott & Frantz, Inc. for purchase of a Vanguard Street Sweeper, cost \$63,450.00 less trade allowance \$11,670.00 - net price \$51,780.00. Motion carried.

Moved Mr. Madsen seconded Mr. Linn the Manager be authorized to negotiate \$36,000. loan with Gettysburg National Bank to finance sweeper purchase. Motion carried.

Ordinance Committee recommendation that anything placed in the Borough right-of-way require a permit was discussed but no action taken on the matter.

Utility Committee to consider placing an additional street light in Dobbin Alley.

Motion by Mr. Linn seconded Mr. Madison the following appointments be made:  
Gettysburg Municipal Authority - Allen I. McDonnell-5 yr-term expires December 1989  
Gettysburg School Board Authority - Ralph W. Guise-5 yr-term expires December 1989  
Planning & Zoning Commission-Andrew M. Larson-5 yr- term expires December 1989  
Zoning Hearing Board-Andrew M. Larson-3 yr- term expires December 1987. Motion carried.

Mr. Ditzler reported on recent survey made by Safety Committee, Mayor Heflin and Police Chief -

1. Decided no changes in "No Turn on Red" signs
2. Yield signs on Square - Mr. Hartzell suggested flashing lights - no decision
3. "Walk" & "Don't Walk" lights at Baltimore and Middle Street intersection was discussed. Mr. Sterner reported cost would be approximately \$10,000. no decision
4. At York/Stratton and Carlisle/Water Street intersections the "No Parking Anytime" signs be replaced with "No Parking Here to Corner" signs
5. Mark roadway to show Thru Street on Constitution Avenue north of W. Lincoln Ave.
6. West Lincoln Avenue - an ordinance be drawn to prohibit parking 2 AM - 6 AM on south side from Carlisle Street west to College Avenue.
7. Proposed Gettysburg Tours bus route will require removal of 4 meters. It was suggested the lost meter revenue and cost of bus stop signs be charged to Gettysburg Tours.

Moved Mr. Ditzler seconded Mr. Hartzell an ordinance be drawn to prohibit parking on the south side of West Lincoln Avenue from 2 AM to 6 AM, effective June 1985. Motion carried by majority vote.

Moved Mr. Witt seconded Mr. Ditzler Council approve the 1985 Highway-aid Budget, in the amount of \$82,333.00. Motion carried.

Moved Mr. Witt the Borough Manager advertise for bids for road building materials and equipment rental. Bids to be opened at February meeting and awarded at the March meeting. Motion carried.

Moved Mr. Madsen seconded Mr. Schmitt all approved bills and payrolls be paid. Motion carried.

Moved Mr. Madsen seconded Mr. Ditzler Council accept the proposal of the Wage & Salary Board and set the salaries retro-active to January 1, 1985. Motion carried.

Moved Mr. Madsen seconded Mr. Schmitt the CPA firm of Frank Ruth be appointed to conduct the 1985 audit. Motion carried.

Moved Mr. Madsen seconded Mr. Delzingaro Council approve the exoneration requests of Anne L. Faber, tax collector, \$90.00 per capita and \$41.00 occupation taxes. Motion carried.

Mrs. Daniels commented she favored the Borough reversing its policy and permit sledding on Springs Avenue following an adequate snowfall. No action taken however several alternate sites were mentioned.

Moved Mr. Delzingaro seconded Mr. Madsen Council adopt the Ordinance limiting height of buildings in the Historic District. Motion carried by majority vote, Mr. Hartzell and Mr. Witt dissenting.

Borough Manager's report:

1. The Revenue Sharing Funds allocation has been decreased by \$6,100.
2. The matter of flashing signals at Meade School has been referred to School Board for any assistance they can provide.
3. If the Borough receives the \$138,000 Community Block Grant, the Fahnestock Building would be eligible for funding also the up-grading of the restrooms at the Rec Park would qualify. Mr. Sterner to contact Karl Gabler Associates to prepare the application.

February 6, 1985 at 3:30 PM was chosen as time for the Public Hearing to receive comments from the public re: use of grant funds.

Moved Mr. Ditzler seconded Mr. Madsen the December and annual reports of the Mayor, Police Chief and Code Enforcement Officer and the December report of the Treasurer be approved as read. Motion carried.

Moved Mr. Hartzell seconded Mr. Madsen the annual report of HARB be approved. Motion carried.

Moved Mr. Witt seconded Mr. Madsen the December and annual report of the Gettysburg Fire Company be approved. Motion carried.

Moved and seconded meeting adjourn at 9:50 PM. Motion carried.
