WHEREAS, recent Statutes require that Andy can no longer serve on both boards, forcing him to resign his position as chairman of the Zoning Hearing Board, and

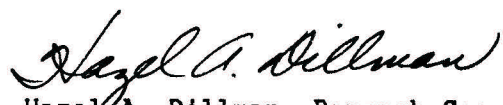
