Mr. Eline reported for the Community Development Committee that the CDBG applications have been filed. A reply could come by July or August. Also the RFP's have been sent to interested parties for the site preparation work for the former Brandon Trailer Court property. The Committee discussed the status of Kennie's Markets and the desire to keep the store in the Borough for the benefit of our citizens.

Ms. Giles suggested that Council be very involved in the process of the Giant Store move. to be more aggressive in our attempts to keep Giant or Kennies open for citizens. She feels Council must do as much as possible and get the public involved.

Mr. Eline will contact P.K. Hoover of Kennie's Market and also a representative from Giant to attend the next Community Development meeting.

Moved Mr. Schmitt, seconded Mr. Troxell to pay all bills and payrolls for the month. Motion carried unanimously.

Mrs. Simpson reported that Mr. Patti has not returned any calls made by Manager Sterner. The Realtor has not had any offers to purchase th_property. Council authorized Solicitor Oyler to Proceed with the sheriff sale on Mr. Patti's property on Middle Street.

Ms. Weaver reported that the Adams County Borough's Association will be meeting on May 19. The speaker will be Shelley Houck of PASB.

Moved Mrs. Gustafson, seconded Mr. Woodward to accept the G. H. Harris exoneration report for tax year 1995. Motion carried unanimously.

Mr. Persson reported that the Mama Ventura project will soon be complete. This was another loan program arranged by Main Street Gettysburg for funding. Main Street still has interested persons looking in the downtown area to purchase property to open various businesses.
