BOROUGH OF GETTYSBURG TROXELL COUNCIL CHAMBERS 59 EAST HIGH STREET, GETTYSBURG, PA 17325 COUNCIL PUBLIC HEARING MINUTES (VACATE ALLEY) SEPTEMBER 27, 2021

President Wesley Heyser called the meeting to order at 6:30 PM with the following Councilors present: Vice President Matthew Moon; Mrs. Judith Butterfield, Ms. Patricia Lawson, Mr. John Lawver and Mr. Nicholas Redman. Mr. Christopher Berger arrived late for the meeting. Staff present included: Mayor Theodore Streeter; Borough Manager Charles Gable; Assistant Borough Manager/Secretary Sara Stull; Borough Solicitor Harold Eastman, Barley Snyder; Planning Director Carly Marshall; and Public Works Director Robert Harbaugh.

Others present included: Attorney Bernard Yannetti of Hartman & Yannetti; Richard Kelley, 215 West High Street; Jim Hale representing the *Gettysburg Times*; and filming conducted by Community Media-ACCTV.

President Wesley Heyser opened the meeting and announced that the purpose of the hearing is for the Borough Council to receive information relative to a Petition to Vacate an Alley filed by Gemmell, LLC, Kelaco, and Randall B. Inskip and Judith L. Inskip, who are requesting Borough Council vacate an unopened alley abutting real estate located at 123 East Franklin Street, 215 and 219 West High Street and real property located to the rear of West High Street along West Legion Alley in the Borough of Gettysburg. The location of the unopened alley is between West High Street and West Legion Alley.

Attorney Bernard Yannetti representing Gemmell, LLC, owner of High Street Brews, 219 West High Street; Kelaco, 123 East Franklin Street; and Randall and Judith Inskip with property located to the rear of West High Street. He represents three of the four that are petitioning the Borough of Gettysburg to vacate an alley between West High Street and West Legion Alley (see attached petition).

Solicitor Eastman explained that the purpose of the hearing is to hear any comments from citizens that may be affected as a result of vacating the public alley. He noted that the alley was never opened or ordained as a public alley. Solicitor Eastman read Section 1732 of *The Borough Code* that "Any person or persons, constituting a majority in number and interest of the owner of the real estate abutting upon any area may petition the council to open such area as a street or portion thereof. Council shall hold a hearing upon such petition, following at least fifteen days' notice to all owners of abutting real estate not joining in such petition, and following at least fifteen days' notice thereof in a newspaper of general circulation in the borough. Following such hearing council shall either by motion deny such petition or by ordinance open, or lay out and open such street or portion thereof. All provisions of section 1731 hereof applicable to ordinances enacted by authority of that section shall apply to ordinances enacted by authority of this section". Borough Council will then need to make a motion to either open or vacate the alley.

Councilwoman Lawson asked if the Borough has ever done any maintenance work on this strip of land in question. Public Works Director Harbaugh began work at the Borough in 2005, and said that they have not done any work at this property during this time. He noted that he spoke with Gettysburg Municipal Authority Utility Manager Mark Guise who said that they have no future use for service at this location. Councilman Lawver who formerly worked for the Borough for 29 years said that they have never done any work during his tenure.

Richard Kelley, 215 West High Street expressed his concerns with vacating the alley. He said that he has owned his property since the 1980's and his tenants must use the alley to get to the rear of the property. By using this alley, his tenants have access from High Street to Legion Alley. There is no guarantee that they would be permitted to use the alley as Attorney Yannetti has told him. Mr. Kelley said that he is not opposed to vacating the alley but wants to be guaranteed that they can still use it.

Councilman Redman asked what plans have been made for the strip of land and if the other property owners would be allowed to use the alley. Attorney Yannetti responded that High Street Brews have made no plans for the strip of land.

Moved Ms. Lawson, seconded Mr. Moon in confirmation of its intention to grant the Petition, as presented at this public hearing, the Borough Council directs that a motion be placed on the agenda for the October 12, 2021 monthly general business meeting of the Council for consideration and formal action directing the solicitor to prepare an ordinance and publish the same for intended enactment at the November monthly general business meeting for the purpose of vacating and canceling the laying out of the subject unopened alley consistent with the Petition to Vacate an Alley filed by Gemmill, LLC, Kelaco, and Randy B. Inskip and Judith L. Inskip, a majority in number and in interest of owners of real estate abutting the unopened alley. Motion carried unanimously.

President Wesley Heyser adjourned the public hearing at 7:08 PM.
