## BOROUGH OF GETTYSBURG 59 EAST HIGH STREET, GETTYSBURG, PA 17325 COUNCIL SPECIAL MEETING AND PUBLIC HEARING APRIL 9, 2018

President Susan Naugle called the public hearing to order at 6:30 PM with the following Councilors present: Vice President Jacob Schindel, Mr. Wesley Heyser, Ms. Patricia Lawson, Mr. Christopher Berger, Mr. Charles Strauss and Mr. John Lawver. Staff present included: Mayor Theodore Streeter; Borough Manager Charles Gable; Borough Secretary Sara Stull and Solicitor Harold Eastman.

Others present include: Matthew Andersen, Esquire, of Norris McLaughlin & Marcus, P.A.; Linda Atiyeh and Peggy Rock representing Gallery 30, 26 York Street; Darlene Brown, 40 South Street; Sharon Monahan, 114 West Broadway; Nancy and Kurt Kramer, 12 Wade Avenue; Cathy Harner, 51 White Church Road; and Becka Fissel, Borough Parking Enforcement Officer. Representing the press was Jim Hale with the *Gettysburg Times*.

Councilwoman Naugle announced that the purpose of this special meeting is to conduct a public hearing in order for the Borough Council of the Borough of Gettysburg to receive comments and recommendations of interested individuals residing within the Borough of Gettysburg concerning the request of the Applicant, Linda Atiyeh, or her assigns, for the intermunicipal transfer of a Restaurant Liquor License (License No. R-15970; LID 63491) from premises located in the Borough of Bonneauville at 55 East Hanover Street for proposed use by the Applicant at premises located in the Borough of Gettysburg at 3 Chambersburg Street and for the purpose of the Borough Council rendering a decision to either approve or disapprove the Applicant's request for an intermunicipal transfer of the liquor license.

Solicitor Eastman noted that this process is required by the Liquor Control Board for the intermunicipal transfer of a liquor license.

## Public Hearing:

Matthew Andersen, Esquire, of Norris McLaughlin & Marcus, P.A., representing Linda Atiyeh, addressed Borough Council stating that she hopes to obtain the Liquor License currently held by Zippers Bar located at 55 East Hanover Street in Bonneauville. The request is for the Intermunicipal Transfer of a Restaurant Liquor License (License No. R-15970; LID 63491) from Zippers to premises located at 3 Chambersburg Street in the Borough of Gettysburg.

Attorney Anderson said that details haven't been finalized yet for the new restaurant. He said that they plan to serve lunch and dinner, but would not be open after midnight. Attorney Anderson noted that the license is valid from 7:00 AM to 2:00 AM.

At this time President Naugle gave the opportunity for interested individuals residing within the Borough of Gettysburg to provide comments and recommendations to the Borough Council concerning the intent of the Applicant, Linda Atiyeh, or her assigns, to transfer the

Restaurant Liquor License into the Borough of Gettysburg for use at premises located at 3 Chambersburg Street, Gettysburg, Adams County, Pennsylvania.

There were no comments made at this time.

Moved Mr. Heyser, seconded Mr. Schindel to adjourn the public hearing at 6:40 PM to begin the special meeting. Motion carried unanimously.
