# MONDAY – MAY 15, 2017 SPECIAL COUNCIL MEETING – 7:00 PM BOROUGH COUNCIL CHAMBERS

President Robert Krummerich called the Special Meeting of Borough Council to order at 7:00 PM with the following Councilors present: Vice President Scot Pitzer, Mrs. Susan Naugle, Mr. Graham Weaver, Mr. Jacob Schindel, Mrs. AmyBeth Hodges, Mr. Wesley Heyser and Mayor Theodore Streeter. Staff present included: Manager Charles Gable; Solicitor Harold Eastman; Parking Manager Karen Mesher; and Becky LaBarre, Director of Planning and Historic Preservation.

Others present included: Borough Planning Commission members Charles Strauss and Sara Kipp; Robert A. Sharrah of Sharrah Design Group, Inc.; and Director Deb Adamik of Main Street Gettysburg. Representing the press was Jim Hale of the *Gettysburg Times*.

President Krummerich explained that the purpose of this special meeting was to discuss the litigation filed in the United States District Court for the Middle District of Pennsylvania to docket No. 17-cv-277 captioned Brandi Courtesis vs. Borough of Gettysburg et.al., to ratify the terms of the settlement negotiated by the Borough's insurance defense Counsel, and to authorize the execution and delivery of a settlement agreement and release consistent with the terms and conditions of the settlement as reviewed by Borough Council.
