# BOROUGH OF GETTYSBURG 59 EAST HIGH STREET, GETTYSBURG, PA 17325 COUNCIL WORK SESSION MINUTES NOVEMBER 27, 2017

President Robert Krummerich called the meeting to order at 7:00 PM with the following Councilors present: Mrs. Susan Naugle, Mr. Graham Weaver, Mr. Jacob Schindel and Mr. Wesley Heyser. President Robert Krummerich announced an executive session of the Borough Council was conducted immediately prior to the adjournment of November 13, 2017 Council business meeting consistent with sections 708(a)(1), 708(a)(3), 708(a)(4), and 708(a)(5) of the Sunshine Act for the following reasons and purposes: (1) to discuss matters involving the employment, the appointment or termination of employment, the qualification for employment, the terms and conditions of employment, the evaluation of performance, promotion or discipline of employees, to include staffing levels and salaries of current non-union employees of the Borough; (2) to receive information relative to the possible purchase or lease of real property by the Borough; (3) to consult with its professional advisors regarding information in connection with issues on which identifiable claims or complaints have been made or are expected to be filed; and (4) to review and discuss items of Borough business which, if conducted in public, would either violate a lawful privilege or lead to the disclosure of confidential information.

### **Public Comments:**

**Mike Shestok, 264 Baltimore Street,** addressed Council regarding the 2018 Budget and asked them to review the Non-Profit Organizations appropriations before finalizing it. He pointed out the good article in the *Gettysburg Times* about Main Street Gettysburg and the many services that they provide to the Borough.

**Shari Brandt, 241 South Washington Street**, addressed Council regarding parking tickets that she received for parking in front of her garage on Washington Street. It's a non-marked parking space so no one is allowed to park there. She asked Council for permission to park in front of her garage. Mayor Streeter and Manager Gable had spoken with her and explained that if parking were changed to allow parking in specific areas then anyone could park at the space. The Residential Parking Permit Program (RPP) also doesn't guarantee parking for the residents on the street.

**Susan Paddock, Chair of No Casino,** addressed Council regarding the casino. She stated that "by not opting out to prevent a Category 4 Casino may represent a failure of your responsibility as a trustee to protect our historic resources as set forth in the PA Constitution". She said that by opting out would allow more time to study the issue.

Many of the audience members also asked that Council choose the opt-out option contained in the state legislation that was signed into law on October 30th. This will leave it open for future Councils to decide what to do.

Council members were in favor of the opt-out option and agreed to place the item on the December Council agenda.

### **PBS 2017-1 LERTA**

Manager Gable reported that the GMS Consultants have been meeting with the stakeholders, and said that they continue to work on the abatement schedule. He said that the LERTA Ordinance will not be ready for a vote before the New Year.

## **PBS 2017-2 ROR Rezoning Amendments**

Manager Gable said that Council needs to provide the Planning Commission with the timeline and what the preferences are.

Charles Strauss noted that the Planning Commission met on November 20<sup>th</sup> for approximately 3 hours to review over 75 pages regarding the ordinance. He suggested that Council and the Planning Commission both review simultaneously.

Manager Gable reported that this also continues to be reviewed by the Planning

Commission.

**PBS 2017-4 Sign Ordinance Revisions** 

Councilwoman Naugle and Councilman Heyser said that there is nothing new to
