Central PA LGBTQ+ Equality Exhibit – Ms. Wertzberger informed all of a traveling exhibit coming to Gettysburg College, Musselman Library from September 26, 2022 to October 13, 2022 titled "The Long Road to LGBTQ+ Equality in PA". A reception for the exhibit would be held on September 27, 2022. Ms. Wertzberger requested invites for sitting Borough Council members and the HRC.

Adams County Fair Housing – Chairperson Riggs shared that @Home in Adams County was partnering with Adams County's Director of Fair Housing and Commercial Property Division of the Pennsylvania Human Relations Commission for a Zoom presentation titled "Fair Housing Rights, Specifically Fair Housing Fundamentals". Gettysburg College Staff Changes – Ms. Wertzberger updated the Commission on staff changes within the College; including a new Chief Diversity Officer.
