Exterior HVAC units to be installed under/beneath the fire escape to screen the units from the main roadway. Add 3 wooden privacy fence panels along the side yard adjacent to the rear deck attaching to the existing 4' high fence. All applications must meet the Department of Interiors Historic Restoration Guidelines.

# e. COA 23-0012 MINOR PROJECT – 200 S. Stratton Street – The Nether Group.
