The draft Gettysburg Borough Sign Ordinance of 2023, which is intended to supersede, supplant and replace the current Borough sign ordinance, may be examined without charge or obtained for a charge not greater than the cost thereof at the Office of the Borough of Gettysburg from the Borough Secretary during regular business hours (Monday through Friday, 8:00 A.M. – 5:00 P.M.).
