The purpose of this special meeting is to conduct a public hearing in order for the Borough Council to receive comments and recommendations of interested individuals residing within the Borough of Gettysburg concerning the request of Sign of the Buck, LLC, for the intermunicipal transfer of a Restaurant Liquor License No. R-18873 from 8 Center Square, New Oxford, PA 17350 (previously issued to Park Hotel, Inc., Licensee) for a restaurant use at premises located in the Borough of Gettysburg at 27 Chambersburg Street, first floor of the James Gettys Hotel building, for the purpose of the Borough Council rendering a decision to either approve or disapprove the request for an intermunicipal transfer of the liquor license.
