The Borough Council of the Borough of Gettysburg, Adams County, Pennsylvania will hold a public hearing on Tuesday, November 13, 2018 commencing at 6:30 p.m. in the Council Chambers at the Gettysburg Borough Municipal Office Building located at 59 East High Street, Gettysburg, Adams County, Pennsylvania 17325. The purpose of the public hearing is to receive public comment relative to the intention and desire of the Borough of Gettysburg to organize and form a municipal authority entitled the Gettysburg Borough Storm Water Authority. The purpose of the Gettysburg Borough Storm Water Authority will be the administration and assessment of related fees in connection with the construction, operation, maintenance and repairs necessary for the implementation and operation of the Borough's municipal separate storm sewer system and program.

It is the intention of the Borough Council of the Borough of Gettysburg to consider and vote upon the publication of an ordinance for subsequent enactment for the purpose of organization and formation of the Gettysburg Borough Storm Water Authority and to authorize the execution and the filing with the Pennsylvania Department of State of Articles of Incorporation for the proposed authority. Such consideration and action will be taken at a general business meeting of the Borough Council to be held immediately following the public hearing on Tuesday, November 13, 2018 commencing at 7:00 p.m.
