

Resolution No. 2206

WHEREAS, Ada G. Lewis was elected to a four (4) year term as tax collector of the Borough of Gettysburg in the November 2001 municipal election with said term of office expiring in January 2006; and

WHEREAS, no registered elector of the Borough of Gettysburg qualified for the office of tax collector of the Borough of Gettysburg for the four (4) year term of office commencing in January 2006; and

WHEREAS, due to the failure of a registered elector to be elected to and to qualify for the office of tax collector of the Borough of Gettysburg for the term of office commencing in January 2006, the Borough Council of the Borough of Gettysburg at its organization meeting held on January 3, 2006 declared a vacancy in the office of tax collector of the Borough of Gettysburg; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to appoint a qualified, registered elector of the Borough of Gettysburg to fill the vacancy in the office of tax collector of the Borough of Gettysburg consistent with Section 901 of The Borough Code until the first Monday in January after the first municipal election occurring more than sixty (60) days after the vacancy occurs at which election an eligible person shall be elected to the office of tax collector for the remainder of the four (4) year term which commenced in January 2006.

WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg hereby appoints ADA G. LEWIS to the office of tax collector of the Borough of Gettysburg to fill the vacancy created by the failure of a registered elector to be elected to and to qualify for said office until the first Monday in January after the first municipal election occurring more than sixty (60) days after the vacancy occurs at which election an eligible person shall be elected to the office of tax collector for the remainder of the four (4) year term which commenced in January 2006.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint a registered elector of the Borough to fill the vacancy in the office of tax collector as found in Section 901 of The Borough Code.

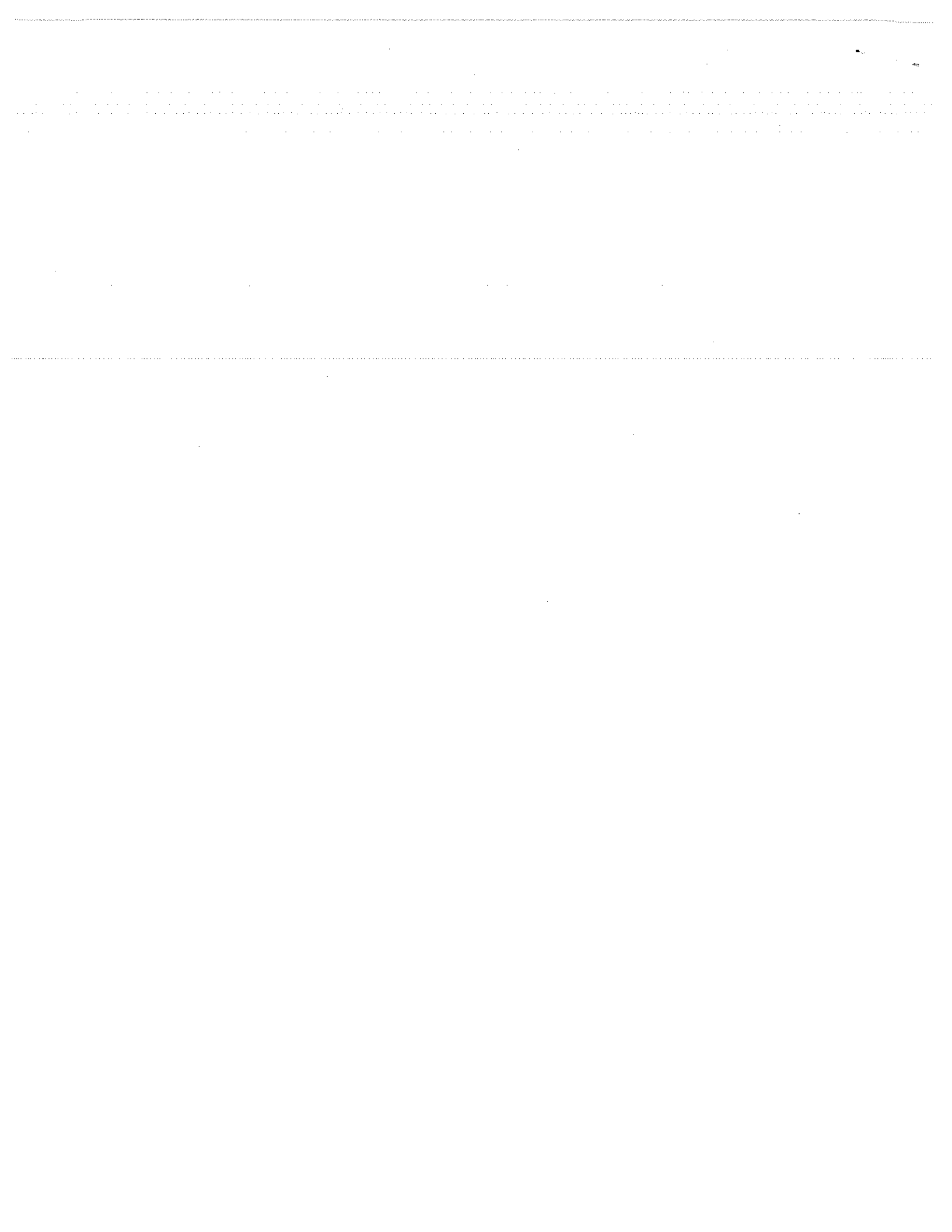


