

RESOLUTION NO. 020816

WHEREAS, on December 9, 2013, the Borough Council of the Borough of Gettysburg appointed by Resolution No. 120913-2 Walton V. Davis as a member of the Zoning Hearing Board of the Borough of Gettysburg for a five (5) year term commencing on January 1, 2014 and expiring on December 31, 2018; and

WHEREAS, on January 6, 2016, Walton V. Davis, due to his termination of residency from the Borough of Gettysburg on or about January 21, 2016, tendered his resignation as a member of the Zoning Hearing Board of the Borough of Gettysburg; and

WHEREAS, as a result of the termination of residency from the Borough of Gettysburg of Walton V. Davis and his resignation as a member of the Zoning Hearing Board of the Borough of Gettysburg, a vacancy has been created in the office of the membership of the Zoning Hearing Board; and

WHEREAS, pursuant to section 903(a) of the Pennsylvania Municipalities Planning Code, the governing body of a municipality is authorized to appoint by resolution residents of the municipality as members to its zoning hearing board and to make such appointments in order to fill vacancies on its zoning hearing board for the unexpired portions of the terms of office of such members; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to appoint a resident of the Borough of Gettysburg as a member of the Zoning Hearing Board of the Borough of Gettysburg in order to fill the vacancy in such office on the Zoning Hearing Board created by the termination of residency from the Borough of Gettysburg and the resignation from office of Walton V. Davis and to serve as a member of the Zoning Hearing Board for the remainder of the unexpired term of office of Mr. Davis.


WHEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby appoint Darlene A. Brown, a resident of the Borough of Gettysburg, as a member of the Zoning Hearing Board of the Borough of Gettysburg in order to fill the vacancy in such office created by the termination of residency from the Borough of Gettysburg and the resignation from office of Walton V. Davis and to serve for the remainder of the unexpired term of office of Mr. Davis as a member of the Zoning Hearing Board which term will expire on December 31, 2018.

This action is taken under and pursuant to the power and authority of the Borough Council of the Borough of Gettysburg to appoint residents of the Borough of Gettysburg to serve as members of the Zoning Hearing Board of the Borough of Gettysburg and to make


such appointments in order to fill vacancies on such Zoning Hearing Board pursuant to section 903(a) of the Pennsylvania Municipalities Planning Code.
