

**RESOLUTION NO. 030810-3**

**WHEREAS**, the Borough Council of the Borough of Gettysburg has adopted, enacted and ordained its Code Enforcement Appeals Board Ordinance on March 8, 2010; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint Marion Ruff to the Code Enforcement Appeals Board for a term commencing on March 8, 2010 and expiring on March 15, 2013; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint Kenneth C. Kime, Jr. to the Code Enforcement Appeals Board for a term commencing on March 8, 2010 and expiring on March 15, 2014; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint Barry Bernas to the Code Enforcement Appeals Board for a term commencing on March 8, 2010 and expiring on March 15, 2015; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint Gareth V. Biser as an alternate to the Code Enforcement Appeals Board for a term commencing on March 8, 2010 and expiring on March 15, 2013; and

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Paul M. Kendlehart to serve as a member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2011.

**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Stephen Snyder to serve as a member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2012.

**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Marion Ruff to serve as a member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2013.

**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Kenneth C. Kime, Jr. to serve as a member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2014.

**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Barry Bernas to serve as a member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2015.


**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Gareth V. Biser to serve as an alternate member of its Code Enforcement Appeals Board for a term commencing on March 8, 2010 and to expire on March 15, 2013.


