

**RESOLUTION NO. 031113 - 2**

**WHEREAS**, the Borough Council of the Borough of Gettysburg adopted, enacted and ordained its Code Enforcement Appeals Board Ordinance, Ordinance No. 1372-10, on March 8, 2010, which ordinance is codified at Chapter 1, Part 6 of the Code of Ordinances of the Borough of Gettysburg; and

**WHEREAS**, pursuant to Section 1-623.B. of the Code of Ordinances of the Borough of Gettysburg (Section 3.B. of the Code Enforcement Appeals Board Ordinance), the Borough Council of the Borough of Gettysburg may appoint by resolution at least one (1) but no more than three (3) resident property owners of the Borough to serve as alternate members of the Code Enforcement Appeals Board of the Borough of Gettysburg for terms of office of three (3) years; and

**WHEREAS**, Gareth V. Biser was appointed to serve as an alternate member of the Code Enforcement Appeals Board of the Borough of Gettysburg by the Borough Council of the Borough of Gettysburg for a term of three (3) years which term expires on March 15, 2013; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint Clodius H. Willis to the Code Enforcement Appeals Board of the Borough of Gettysburg as an alternate member for a three (3) year term commencing on March 16, 2013 and expiring on March 15, 2016.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Clodius H. Willis to serve as an alternate member of the Code Enforcement Appeals Board of the Borough of Gettysburg for a three (3) year term commencing on March 16, 2013 and expiring on March 15, 2016.

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint resident property owners of the Borough to serve as alternate members of the Code Enforcement Appeals Board of the Borough of Gettysburg pursuant to Section 1-623.B. of the Code of the Code of Ordinances of the Borough of Gettysburg (Section 3.B. of the Code Enforcement Appeals Board Ordinance).
