

RESOLUTION NO. 31306-3

**A RESOLUTION OF THE BOROUGH OF GETTYSBURG,  
ADAMS COUNTY, PENNSYLVANIA, INCREASING FEES  
FOR EACH PLAN EXAMINATION, BUILDING PERMIT,  
MOVING OR DEMOLITION PERMIT AND INSPECTION  
UNDER THE BUILDING CODE OF THE BOROUGH OF  
GETTYSBURG.**

**WHEREAS**, the Borough Council of the Borough of Gettysburg adopted Ordinance No. 1172-95 requiring that a fee for each plan examination, building, moving or demolition permit and inspection shall be paid in accordance with a schedule of fees, fixed from time to time by resolution of Borough Council; and

**WHEREAS**, by Resolution adopted January 9, 1995, the Borough Council of the Borough of Gettysburg fixed the current fees and costs for obtaining a building permit pursuant to the aforesaid Ordinance No. 1172-95; and

**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to adopt a Resolution increasing fees for each plan examination, building permit, moving or demolition permit and inspection under the Building Code.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg does hereby fix the following fees for each plan examination, building permit, moving or demolition permit and inspection under the Building Code of the Borough of Gettysburg:

A. For a building permit, Twelve (\$12.00) Dollars for up to One Thousand (\$1,000.00) Dollars of construction cost; for construction cost of over One Thousand (\$1,000.00) Dollars, an additional Ten (\$10.00) Dollars per each One Thousand (\$1,000.00) of construction cost. The minimum permit fee hereunder shall be Twelve (\$12.00) Dollars.

B. For a building permit for the moving of a building or structure from one lot to another or to a new location on the same lot Twelve (\$12.00) Dollars per One Thousand (\$1,000.00) Dollars of estimated cost of moving plus the cost of the new foundation and of all work necessary to place the building or structure in its completed condition at the new location; for moving cost of over One Thousand (\$1,000.00) Dollars, an additional Ten (\$10.00) Dollars per each One Thousand (\$1,000.00) of moving cost plus the cost of the new foundation and of all work necessary to place the building or structure in its completed condition at the new location. The minimum permit fee hereunder shall be Twelve (\$12.00) Dollars.


C. For a permit for the demolition of a building or structure Fifty (\$50.00) Dollars for the first 2500 square feet of demolition and Twenty-Five (\$25.00) Dollars for each additional 2500 square feet of demolition. The minimum permit fee hereunder shall be Fifty (\$50.00) Dollars.

D. If any work is commenced prior to obtaining a permit for which fees are provided in this Resolution, a penalty shall be assessed in an amount equal to the permit fee which shall be paid in addition to the actual permit fee assessed under this Resolution.


E. The permit fees set forth in this Resolution shall take effect upon adoption.
