

RESOLUTION NO. 31405-1

A RESOLUTION OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPROVING THE INTERMUNICIPAL TRANSFER OF LIQUOR LICENSE TO DISPENSE BEER (LICENSE NO. E-3394) PURSUANT TO APPLICATION OF GIOVANNI CUCUZZA FOR USE IN HIS RESTAURANT LA BELLA ITALIA UPON ITS RECONSTRUCTION AT PREMISES LOCATED AT 402 YORK STREET, GETTYSBURG BOROUGH, ADAMS COUNTY, PENNSYLVANIA.

WHEREAS, Giovanni Cucuzza (the "Applicant") has filed an Application with the Pennsylvania Liquor Control Board for the intermunicipal transfer of Liquor License No. E-3394 from premises located at 2650 Buchanan Valley Road, Orrtanna, Adams County, Pennsylvania to premises located at 402 York Street, Borough of Gettysburg, Adams County, Pennsylvania; and

WHEREAS, the Applicant proposes to use said Liquor License No. E-3394 to dispense beer at his restaurant, La Bella Italia, upon its reconstruction at the premises located at 402 York Street, Borough of Gettysburg, Adams County, Pennsylvania; and


WHEREAS, consistent with the requirements of 40 Pa. Code § 7.61(2), the Borough Council of the Borough of Gettysburg conducted a duly advertised public hearing on March 14, 2005 for the purpose of receiving comments and recommendations of interested individuals residing within the Borough of Gettysburg concerning the Applicant's intent to transfer the liquor license into the Borough of Gettysburg.

RESOLVED, based on the comments and recommendations received at the public hearing held on March 14, 2005, the Borough Council of the Borough of Gettysburg finds that the intermunicipal transfer of Liquor License No. E-3394 to premises located at 402 York Street in the Borough of Gettysburg, Adams County, Pennsylvania will not adversely affect the welfare, health, peace and morals of the Borough or Gettysburg or its residents.




