

**RESOLUTION NO. 041210-6**

**A RESOLUTION OF THE BOROUGH OF GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA, APPOINTING A BUILDING CODE OFFICIAL FOR THE ADMINISTRATION OF THE UNIFORM CONSTRUCTION CODE AND A CODE ENFORCEMENT AGENCY FOR THE ENFORCEMENT OF THE UNIFORM CONSTRUCTION CODE.**

**WHEREAS**, the Borough of Gettysburg (hereinafter referred to as the "Borough") has, by Ordinance No. 1292-04 enacted on June 14, 2004, adopted the Uniform Construction Code as the municipal building code of the Borough of Gettysburg in conformity with the Pennsylvania Construction Code Act and the regulations promulgated thereunder by the Pennsylvania Department of Labor and Industry (hereinafter collectively referred to as the "Code"); and

**WHEREAS**, the Borough has, by Ordinance No. 1375-10 enacted on April 12, 2010, elected to reverse its opt-out decision and to commence administration and enforcement the Code; and

**WHEREAS**, pursuant to said Ordinances and the Code the Borough is authorized by resolution to appoint such officials and administrators as it deems necessary for the administration and enforcement of the Code to commence such duties on July 12, 2010 or on such earlier date if authorized to do so by the Pennsylvania Department of Labor and Industry.


**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Gettysburg, as follows:

1. The Borough appoints Robert Clem Malot of Commonwealth Code Inspection Services, Inc., as its Building Code Official. The said Building Code Official shall continue to serve in that capacity at the pleasure of the Borough Council of the Borough of Gettysburg until removed or replaced by subsequent resolution.
2. The Borough appoints Commonwealth Code Inspection Services, Inc. of 176 Doe Run Road, Manheim, PA 17545, as its official Code Enforcement Agency. The said Code Enforcement Agency shall continue to serve in that capacity at the pleasure of the Borough Council of the Borough of Gettysburg until removed or replaced by subsequent resolution.
3. This Resolution shall supersede all previous resolutions or ordinances of the Borough to the extent that they are inconsistent with this Resolution.


4. This Resolution shall be effective upon adoption.
