WHEREAS, The Journey Through Hallowed Ground is a public-private partnership dedicated to raising national awareness of the cultural and historic resources throughout the 175-mile long region centered on the Rt. 15/231/20 corridor; and

WHEREAS, The Journey Through Hallowed Ground encompasses 6 presidential homes, 13 National Historic Landmarks, 47 Historic Districts, 15 Main Street Communities, the largest collections of both Civil War Battlefields and Rural Historic Districts in the county, and numerous historic homes and sites; and

WHEREAS, by linking the Main Street communities, historic downtowns, businesses and heritage sites along the corridor, we have an opportunity to celebrate and support this vital fabric of America which also serves to support our existing businesses; and

WHEREAS, Adams County has a rich heritage closely interconnected with that of the entire corridor, and is home to many historic sites of national importance; and

WHEREAS, the Gettysburg Borough Council considers both the heritage of Adams County and a robust local economy essential to the quality of life of its citizenry;

RESOLVED FURTHER, that the Gettysburg Borough Council requests the Pennsylvania Department of Transportation include RT. 15 within the county borders in the State Scenic Byway Program; and, be it

RESOLVED FURTHER, that the Gettysburg Borough Council supports the intention of the Journey Through Hallowed Ground Partnership to seek National Scenic Byway designation for the 175 mile Rt. 15/231/20 corridor.

## FREQUENTLY ASKED QUESTIONS

### WHEN DID THE JOURNEY THROUGH HALLOWED GROUND INITIATIVE BEGIN?

This collaborative, voluntary, initiative began in 1996 as a broad based coalition of public and private organizations to preserve and celebrate the diverse, irreplaceable historic and cultural resources that are contained between Gettysburg and Monticello. In 2004, *The Journey Through Hallowed Ground's* public-private partnership was developed, along with a renewed strategic plan, to increase awareness and support.

### WHO IS INVOLVED?

The National Trust for Historic Preservation, Protect Historic America, the National Park Service, the Civil War Preservation Trust, the Virginia Department of Historic Resources, the Maryland Historical Trust, the Maryland Office of Tourism and Development, Tourism Council of Frederick County, the Adams County, PA Board of Commissioners, the Prince Charitable Trusts, the Trust for Public Land, the Piedmont Environmental Council, the Virginia Tourism Corporation and the Conservation Fund, among others.

### WHERE IS THE JOURNEY THROUGH HALLOWED GROUND?

This 175 mile corridor lies in the mid-Atlantic region of the United States from Gettysburg, PA., to Monticello, VA, west of Washington, DC. The swath of land along the Old Carolina Road corridor, now known as Rt. 15, holds:

- Two World Heritage Sites: Monticello and the Rotunda, University of Virginia
- 13 National Historic Landmarks
- 47 Historic Districts
- Approximately one million acres already on the National Register
- Numerous scenic rivers, roads and landscapes
- 13 National Park Units

#### **WHAT HAS THE JTHG COOPERATIVE DONE SO FAR?**

*The Journey Through Hallowed Ground* partners made substantial progress from the period of 1996-2004. Among the achievements are:

- The publishing of *Hallowed Ground*, a coffee table book
- The completion of a Corridor Resource Inventory
- The launch of the National Park Service Web-based Travel Itinerary "Hallowed Ground" covering Virginia sites along *The Journey*. (Currently being updated to include Maryland and Adams County, PA.)
- Passage of a resolutions of support by the Virginia legislature, the Leesburg Town Council, the Purcellville Town Council, the Albemarle and Fauquier Board of Supervisors, among others.
- Designation of the Rt. 15 Corridor within Maryland as a State Scenic Byway
- Completion of the Rt. 15 Corridor management plan within Maryland and submission of this section of *the corridor* for consideration as a National Scenic Byway

**WHAT ARE THE GOALS AND OBJECTIVES OF THE PARTNERSHIP?**

1. Launch a national awareness campaign to increase awareness of and visitation to the attractions throughout the corridor. This initiative will demonstrate how each segment of *The Journey* can and does "Prosper Through Preservation."
2. Obtain National Scenic Byway designation by 2008.
3. Obtain National Heritage Area designation by 2008.
4. Obtain context sensitive design standards for all road improvements along the corridor from the Virginia, Maryland and Pennsylvania Departments of Transportation.

**WILL THE NATIONAL DESIGNATIONS RESTRICT CURRENT LAND USE?**

No. These designations are honorific and carry neither authority to change nor to restrict zoning regulations. The challenge in preserving and protecting the region encompassed within *The Journey Through Hallowed Ground* is that, while much of the land is recognized as historically, culturally and environmentally significant, the vast majority of the land is privately held. We are working with current land owners to ensure their buy-in into this effort and to create a pool of funding to purchase land at fair market value and/or working in collaborative ways to promote alternative economic models to development.

**WHO WILL BENEFIT FROM THIS EFFORT?**

In the long-term, every citizen in America will benefit, because we will preserve our cultural heritage for future generations to experience

In the short term, an effort that promotes economic development through tourism will benefit individual citizens along the corridor.

Tax revenue through tourism = individual tax payer relief = jobs

This question has multiple answers, each one deserving of the benefit of this effort. But first, look at the beneficial economic impacts of *The Journey Through Hallowed Ground*.

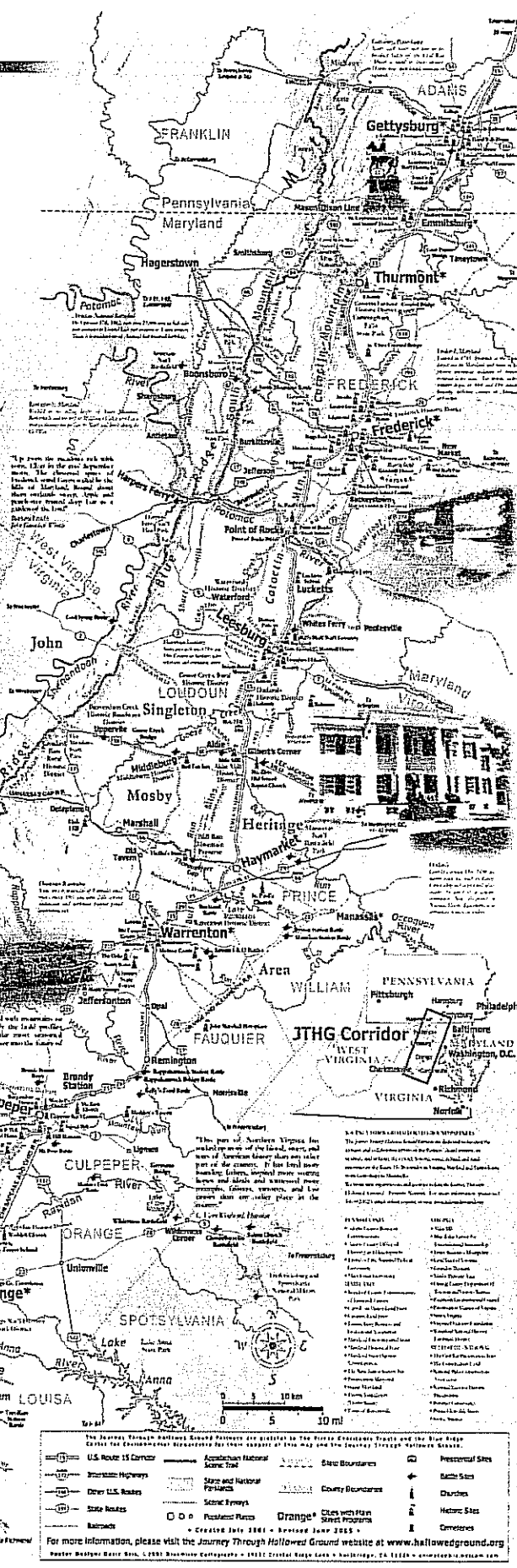

The *Journey Through Hallowed Ground* traverses one of America's most significant heritage corridors. The route stretches 175 miles along the Route 15 corridor from Gettysburg, Pennsylvania through Frederick County, Maryland (changing to Route 20 at Orange, Virginia) and ends at Thomas Jefferson's Monticello near Charlottesville, Virginia. This historic corridor is a treasure to some of the most important places in our country's history, including Native America and African American historic sites, the homes of six U.S. Presidents, more Civil War battlefields than any other region in the country, 47 historic districts, one of the largest collections of Underground Railroad sites in the country, and numerous Main Street Communities.
