

**RESOLUTION NO. 051012**

**WHEREAS**, Alice Estrada has been duly elected and has qualified as a member of the Borough Council of the Borough of Gettysburg representing the First Ward of the Borough of Gettysburg for a four-year term of office until the first Monday of January 2014; and

**WHEREAS**, Alice Estrada is no longer a resident of the Borough, having moved from the Borough on or after April 10, 2012; and

**WHEREAS**, due to her removal from the Borough, Alice Estrada is no longer qualified to be a member of Borough Council and a vacancy has been created on the Borough Council of the Borough of Gettysburg; and

**WHEREAS**, consistent with the provisions of the Borough Code at 53 P.S. §45901 the Borough Council shall fill a vacancy on Borough Council within thirty (30) days by appointing a registered elector of the First Ward of the Borough to hold such office until the first Monday in January after the first municipal election occurring more than sixty (60) days after the vacancy occurs, at which election an eligible person shall be elected to the office for the remainder of the term. No person shall be appointed to fill the vacancy on Borough Council unless he or she has resided within the First Ward continuously for at least one (1) year immediately prior to his or her appointment; and


**WHEREAS**, the Borough Council of the Borough of Gettysburg desires to appoint a qualified, registered elector of the First Ward of the Borough of Gettysburg to fill the vacancy in the office of member of Borough Council representing the First Ward due to the removal from the Borough of Alice Estrada. The person appointed to fill the aforesaid vacancy shall hold such office from the date of this resolution until January 6, 2014 which is the first Monday in January following the November 2013 municipal election and which is also the date of the expiration of the term of office as a member of Borough Council of Alice Estrada.

**WHEREFORE, BE IT RESOLVED**, that the Borough Council of the Borough of Gettysburg hereby appoints Charles M. Teague as a member of the Borough Council of the Borough of Gettysburg representing the First Ward to fill the vacancy created by removal from the Borough of Alice Estrada until January 6, 2014 which is the first Monday in January following the November 2013 municipal election and which is also the date of the expiration of the term of office of Alice Estrada.


This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint a registered elector of the Borough to fill a vacancy on the Borough Council as found in the Borough Code at 53 P.S. §45901.
