

RESOLUTION NO. 05/109-2

**A RESOLUTION OF THE BOROUGH COUNCIL OF
GETTYSBURG, ADAMS COUNTY, PENNSYLVANIA,
APPOINTING A VOTING DELEGATE AND AN
ALTERNATE VOTING DELEGATE TO REPRESENT THE
BOROUGH OF GETTYSBURG ON THE ADAMS COUNTY
TAX COLLECTION COMMITTEE.**

WHEREAS, the Local Tax Enabling Act, Act of December 31, 1965, P.L. 1257, No. 511 (53 P.S. § 6901 et seq.), was amended by Act of July 2, 2008, P.L. 197, No. 32 by the General Assembly of the Commonwealth of Pennsylvania. The provisions of said Act No. 32 of 2008 and The Local Tax Enabling Act, as supplemented from time to time, are hereby incorporated herein by reference as fully as though set forth at length herein; and

WHEREAS, Act 32 of 2008, Act of July 2, 2008, P.L. 197 (hereinafter referred to as the "Act"), mandates the consolidation of the collection of local income taxes; and

WHEREAS, Section 504 of the Act establishes a tax collection district (hereinafter referred to as the "TCD") in each county; and

WHEREAS, Section 505 of the Act provides that each TCD shall be governed by a tax collection committee (hereinafter referred to as the "TCC"); and

WHEREAS, pursuant to Section 505(b) of the Act, the governing body of each political subdivision within a TCD that imposed an income tax prior to July 1, 2009 shall appoint one voting delegate and one or more alternates to represent the political subdivision on the TCC; and

WHEREAS, the Borough Council of the Borough of Gettysburg desires to appoint a voting delegate and an alternate voting delegate to the Adams County TCC.

NOW, THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Gettysburg does hereby appoint Ramona K. Overton as a voting delegate and Robert L. Krummerich as an alternate voting delegate representing the Borough of Gettysburg, Adams County, Pennsylvania on the Adams County TCC pursuant to the Act; and

This action is taken under and pursuant to the power of the Borough Council of the Borough of Gettysburg to appoint a voting delegate and alternate voting delegates to the TCC as found in Section 505(b) of the Act (53 P.S. § 6924.505(b)).


